This issue of the *Upshaw Family Journal* contains all Upshaw references from Atlanta, Fulton County, Georgia, city directories from 1031 through 1949. The next issue will contain Upshaw references from Atlanta city directories for 1950 through 1962. .

Atlanta, Fulton County, Georgia, City Directories 1931-1949

Abstracted from all copies of the Atlanta City Directory for this time period. These are widely available on microfilm and in original form and researchers may refer to those for publisher's names and other citation information as required.

Atlanta City Directories for 1859-1885 were previously printed in *the Upshaw Family Journal*, October 1978, pages 98-100; and those for 1859 through 1930 were previously printed in the *Upshaw Family Journal*, Winter 2021, pages 1-31; all Directories for 1931 through 1949 are included in this issue.

No Directories were published for the years of 1861-1866, 1868, 1869, 1873, 1917 and 1946. There were no Upshaw persons listed in the Directories for 1859 & 1870-1872.

Race shown as "c" (for "Colored") seems to have been indicated in Directories from 1867 through 1952 and it is shown for those years. Given names shown in parenthesis immediately following the Upshaw name is the name of the wife, which was begun in 1901; in some years they seemed not to provide this. The names shown in **BOLD** print are assumed to be "prestige" listings.
