






I am descended from Thomas Streshley, Jr., and his wife, Mary Carber, a daughter of Hannah Carber Upshaw by her first marriage. I don't know a great deal about this line, but have always been interested in it because the last name became a common first name in the family. We spell it

Thrashley, and I have read that it was always pronounced that way. My family left Virginia before the Revolution and settled in South Carolina.

If you have correspondents who are especially interested in the Streshley-Thrashley family, I would enjoy exchanging information with them.

Dear Mr. Brooke;

Since my great grandfather, A. M. M. Upshaw, was mentioned several times in the UFJ, Volume II number 1, I am sending the family group sheets for both of his marriages. My grandfather, Dr. Harney Upshaw, was also married twice, which I may not have mentioned when I sent my lineage chart.

I have no explanation of the "Mancy Hamilton Crockett marriage to Ed Upshaw" record (see UFJ Vol II pg 35); it is no doubt an error. I am satisfied that Mancy Hamilton Crockett and Ann Hamilton Crockett are one and the same person. My great grandmother's birth date on her tombstone inscription is identical with the Crockett Bible records. I grew up with the knowledge that she was of the Tennessee Crocketts. I have her pension record from the National Archives in which she states she was married under the name Ann Hamilton Crockett to Arthur M. M. Upshaw on 19 May 1830 at Columbia, Maury County, Tennessee, by Rev. Dr. Stephens, an Episcopal clergyman. Her brother, Robert Crockett, was with my great grandfather, A. M. M. Upshaw, in Indian Territory. I have no knowledge of A. M. M. Upshaw's early life before they came to Giles County, Tennessee; neither do I have information about his mother, Mary ("Mollie") Hartin - where or when she died or who her parents were.

I enjoy and appreciate the Upshaw Family Journal - it represents a lot of work on the part of many.

Dear Cousin:

Thank you for the new and very good copy of the Upshaw Family Journal.

In this issue (Vol II no. 1) on page 26, the George Upshaw of 1830 Jackson County, Illinois, was my grandfather. He is also listed on page 26 under the Upshaw Query in the Alabama Genealogical Register; his birth date, however, is wrong as listed - he was born in 1802. My grandfather had two brothers named John Upshaw - one by Edwin and Lucy Roane Upshaw and enother by Edwin Upshaw and his second wife, Miss Patsy Harrison; both died as babies or at birth. The John Upshaw listed by Mrs. Hall in the query is incorrect; there was a Dr. John Upshaw and wife Sally who moved from Missouri to Texas, who was a cousin, but not a brother of my grandfather George W. Upshaw.

page 56: Genealogical excerpts taken from <u>Baptist Builders in Louisiana</u>, by John P. Durham and John S. Raymond.

Deacon J. C. Rockett, born 14 Nov 1847, near Vater Valley, Mississippi, married first 1869 to Miss Rebecca Upshaw of Spearsville, who died 1882, and second to Miss Elizabeth Howell; had five children by first marriage and nine by second; lived Spearsville, and died 11 April 1929, buried Camp Creek cemetery.

page 82: From first 52 editions of the <u>Bienville Messenger</u>, published in Sparta, Louisiana, by J. N. A. Scanland; beginning 21 Oct 1865 and ending 13 Oct 1866.

28 Oct 1865; a card, to Mr. James Upshaw, Sheriff of this Parish, and Capt. Graff, Provost Marshall at this place, and also to Col. Campbell, I return my sincere thanks for their kind and generous treatment that I received at their hands, while imprisoned at this place. R. P. Allen, Sparta.

page 86: (continued from above - the <u>Bienville Messenger</u>)
28 July 1866; James Upshaw filed to be appointed administrator of succession of James C. Babers, deceased.

page 87: (continued from above - the <u>Bienville Messenger</u>)
22 Sep 1866; Married on the morning of the 16th inst. at the residence

of the bride's father, by the Rev. J. A. Harrel, Mr. John H. Burk to Miss Tabitha J. Upshaw of this place.

page 471: Winn Parish tax list, 1864. The Winn Parish Courthouse, Winnfield, Louisiana, burned in 1884 and all records prior to that time were lost, with the exception of this tax list.

Allen J. Upshaw appears on the list.

<u>War Between the States, miscellaneous</u> (contributed by Mrs. Sarah Schulz)

Thomas Allen Upshaw (John, Forrester) served in the Confederate army in Company "H", 9th Regiment of Louisiana; discharged 4 Oct 1865.

William W. Upshaw (James, John, Forrester) served in the same unit, Co. "H" of the 9th Regiment, and lost a leg in the Battle of the Wilderness.

Civil War letter (contributed by Mrs. Charlotte D. Parrott)

A Mrs. Watson, in response to my querie in the Shreveport Journal, has knowledge of a letter written circa 1860 to a soldier in the War Between the States, giving news from home, saying "old Mrs. Upshaw is dead". This may have been in reference to Tabitha Lawlis who married John Upshaw in 1818 Elbert County, Georgia, and lived in Bienville Parish, Louisiana. It is unlikely that it was in reference to Ann Faulkner, wife of Forrester Upshaw, who would have been almost 90 years old in 1860.

Bienville Parish

Records of Bienville Parish, Louisiana (contributed by Mrs. Charlotte D. Parrott).

The oldest records of Bienville Parish are in the year 1850. In February 1850 the names of the Parish officers included James Upshaw as assessor. In January 1854 the names of the Parish officers included James Upshaw as collector. In Movember 1861, election results show 644 votes for Jefferson Davis for President, etc, and James Upshaw, Sheriff. 1866 election results show James Upshaw, Sheriff. Confederate soldiers of the Parish included T. A. Upshaw.

There was a newspaper named The Jeffersonian, which was published in Bienville Parish when the Parish seat was Sparta, but I have not been able to find any extant copies of this newspaper.

Records of Sparta, Parish seat of Bienville Parish, Louisiana. (contributed by Mrs. Charlotte D. Parrott)

Sparta, in the latitude 32° 19 north and longitude 15° 38 west, was selected in 1849 as the seat of Justice for the newly formed Parish of Bienville. The central location alone recommended this site.

The first record of the town of Sparta is dated 10 May 1852; Ordnance No. 1 adapted at the beginning of this administration proved that slaves found outside the limits of their masters enclosure without pass or permit should be given not more than 30 lashes, not less than 10, well laid on with a switch or cowhide. An order prohibiting the cutting down of trees in the streets, except pine or dead trees, was issued in October, 1852. There is no record of business in 1853.

In Harch, 1854, W. E. Patton was Mayor; J. F. Stephens, P. P. Brinson, T. L. Prothro, J. A. Harrell, and G. W. Alexander were selectmen; John G. Noles was chosen clerk; J. S. Mixon, Treasurer; <u>James Upshaw</u> was Collector; "Allen" Upshaw was Captain of Patrols; etc.

(Bienville Parish, Louisiana - continued)

Miscellaneous references from the office of Court Clerk, Bienville Parish, Arcadia, Louisiana (contributed by Mr. David W. Morgan).

There is no record here of a will or deed records of John Upshaw. There are no official records, but apparently James Upshaw (son of John Upshaw) was Sheriff here from 7 Aug 1865 and served presumably until 16 April 1867, which was the date of the appointment of another Sheriff.

Succession of John B. Markham, deceased (abstracted from loose succession papers in Bienville Parish by Mrs. Charlotte D. Parrott).

Sarah Markham settles the estate of John Markham, her late husband. She names her brother James Upshaw as administrator.

Wherefore petitioner prays that a family meeting be held composing of John Upshaw, T. Allen Upshaw, the only male relatives of said minors in said Parish, and E. N. Warren, S. Eldridge, and John C. Young, friends of said minors to deliberate touching the interest of said minors and to advise.

Hold a family meeting composed of the following persons, to wit: John Upshaw, T. A. Upshaw, E. N. Warren, Lewis Eldridge, and John C. Young, believing and _____ of Permilia Ann, Emily Jane, Tabitha, Fanny M., and John B. Markham, minor children of John B. Markham, dec'd, and issue of his marriage with Sarah Upshaw, to deliberate, advise, and determine whether it would be to the interest of said minor children to sell their interest in the real estate and upon what terms, etc., etc. 18 November 1857.

James Upshaw, admn - in account with the succession of John B. Markham, dec'd. Tutorship of the minor children of J. B. Markham, Clerk of the District Court in and for the Parish and State aforesaid, do hereby certify that Sarah Upshaw, widow of John B. Markham, Leasor. 18 November 1857.

Bienville Parish, Louisiana. To the Hon. Judge of the 17th; Judicial District, State of Louisiana, Parish of Bienville.

The petition of Sarah Upshaw, a resident of the said State and Parish with respect, shows that John B. Markham, late of said Parish dec'd, left the following named minor children, to wit: Ann, Tabitha, James M., John Markham, and Emily J. Markham, issue of his marriage with petitioner who further shows that she has not yet been confirmed as their natural tuition to which she is entitled by law and that the interest of said minors requires that she shall now be confirmed as natural trust of said minors and that some discreet person be appointed as under tutor.

Wherefore she prays that she be now confirmed in her capacity of natural tutor of the above named minors, issue of petitioner's marriage with said dec'd, and that James Upshaw be appointed under tutor of said minors and for all necessary orders and general relief.

That Sarah Upshaw be confirmed as natural tutrix of the minors Ann, Tabitha, James M., John, and Emily J. Markham, children of John B. Markham, issue of his marriage with Sarah Upshaw. It is further ordered that James Upshaw be appointed under tutrix of said minors, etc.

Signed - John F. Stephens, Clerk of the Court.

(Succession Papers of John B. Markham, Bienville Parish, La - continued)

I solemnly swear that I will faithfully discharge and perform duties. Children: Permilia Ann, Emily Jane, Tabitha, James M., and John B. Markham, children of John B. Markham and his widow Sarah Upshaw, according to the best of my knowledge and ability, so help me God. Sworn to and subscribed before Court, 18 November 1857.

Miscellaneous families (contributed by Mrs. Charlotte D. Parrott, who comments that the following may be related to W. W. Upshaw, son of James Upshaw (b 1819 Ga), oldest son of John and Tabitha Lawless Upshaw; these are believed to be sons of James Henry Upshaw, who is buried in Winn Parish, La. According to Henry Upshaw in 1974, his father, James Allen Upshaw, had an uncle who moved to Texas and lived to be 100 years old, whose name or address he does not remember. James Allen Upshaw also had two half brothers, named John Upshaw and Wesley Upshaw).

Letter from Mrs. Eva McDuffie, Monroe, Louisiana; author of <u>History of Brush Valley, Liberty Hill, and Friendship</u> (Bienville Parish, Louisiana) (contributed by Mrs. Sarah Schulz).

"On page 53 of my book is a description made by a tourist from New Orleans, written in 1860 to the Editor of the Crescent, a New Orleans newspaper. He states that in 1860 James Upshaw was Sheriff of Bienville Parish. The 1860 census of Bienville Parish is missing. James Upshaw was probably living at Sparta; if so, his parents were likely buried in the Sparta cemetery, which I can check the records for, as all the volumes of cemetery records published are here in the Monroe Public Library. On pages 29 and 30 of my book, Upshaws are listed as members of Liberty Hill Baptist Church in 1883. An Upshaw was buried in one of the Liberty Hill cemeteries, but was of a more recent date.

I never knew the Upshaws; they had left the Brush Valley - Liberty Hill area before I was born, but in a conversation with James Smitherman, he gave me the impression that some Upshaws lived in the area of Price at one time - no one has copied that cemetery."

Item 2: Reply dated 26 Aug 1925, to above inquirey, giving this record: R. V. Upshaw (also born as Roberson Upshaw, but not as Bod Upshaw), enlisted March 4, 1862, at Newman, Georgia, in Company "B", 1st Georgia Cavalry, C. S. A.; not found as of Company "G" muster roll Nov & Dec 1864 (the latest on file) shows him present, a Private.

Prisoner of War records show that he was paroled at Charlotte, North Carolina, May 3, 1865, in accordance with terms of a Military Convention held on April 26, 1865, a Private.

Item 3: A letter, dated 5 Nov 1925, from Oklahoma Confederate Pension Department to "Hon. T. B. Hogg, Shawnee, Oklahoma", who evidently assisted Ida S. Upshaw in obtaining the pension forms. I have not remarried since his death; I was married to him at Jackson's Gap, Alabama (no date given); He died at Shawnee, Oklahoma (no date given); he never drew a pension. He enlisted in Georgia and served in the First Georgia Cavalry, Company "B", and was paroled in May 1865; he was not a commissioned officer.

Book Reviews

Bounty and Donation Land Grants of Texas, 1835 - 1888; by Thomas Lloyd Hiller, 1967.

Bounty was a land grant made for military service which had been promised in advance of the service as an inducement to enlistment. A specified amount of land was promised to soldiers for certain periods of service.

Donation was a grant of land made by Texas to soldiers for service during the Revolution after the service had been rendered, and which had not been promised to them in advance.

page 649: Samuel W. Upshaw received Bounty Warrant 1168 for 1280 acres from Secretary of War on 20 Dec 1838 for service from 10 Oct 1836 to 19 Dec 1837. 1280 acres in Harris County were patented to him on 22 May 1841. Patent 130 Vol 1, abstract 821, General Land Office file Harris Bounty 48.

No Upshaws are listed under Donation Land Grants.

page 7: The County Organized.

Upshur County was organized by an act of the Texas legislature on July 13, 1846. At the time of the organization it was composed of all of what is now Upshur, Camp and the part of Gregg north of the Sabine River. Upshur County was originally part of Nacogdoches County, but later when Harrison County was organized, it was included in that county, therefore all of Upshur County was detached by Harrison County.

Two presidential cabinet members were honored in the naming of the county and its seat of government.

ABEL PARKER UPSHUR was born in Virginia, June 17, 1791. He served several terms in the Virginia Legislature and in 1826 he was appointed to the Supreme Court of Virginia.

There he served with distinction until 1841 when President John Tyler appointed him Secretary of the Navy. In 1843 he succeeded Daniel Webster as Secretary of State. Here he laid the groundwork for the annexation of Texas to the Union. He was killed on February 28, 1844 in an explosion of the "Peacemaker" which was a large new cannon, on the Navy war cruiser "Princeton". President Tyler was also on board as well as many other distinguished persons at the time of the tragedy.

When the Texas Legislature organized Upshur County, it said the new county should be named in honor of the late cabinet member.

The Lone Star State - A Memorial and Biographical History; History of Johnson and Hill Counties, Lewis, publisher. (contributed by Mrs. M. M. Twitty, who notes that the following is the first portion of a very lengthy article which mainly concerns Samuel C. Upshaw and his activities in State government, etc. Mrs. Twitty further notes that Ann H. (Crockett) Upshaw died in 1898 and her son Samuel Crockett Upshaw died in 1901).

page 473: Capt. Samuel C. (Crockett) Upshaw, Counselor at Law. According to Bacon the greatest trust between man and man is the trust of giving counsel, and in the profession of law the most brilliant talents, most extensive knowledge and the strongest sentiments - moral and spiritual and material - are brought into play, and it's power for good or evil is vast and invincible. Capt. Upshaw is an Attorney of far more than ordinary ability, and is in the active practice of his profession at Hillsboro, Texas.

He was born in Little Rock, Arkansas, Jan. 31, 1840, a son of Col. A. M. M. Upshaw, a native of Essex County, Virginia, who moved to middle Tennessee when a young man, from which state he volunteered in the Indian War of 1836, serving against the Seminoles in Florida, after which he was appointed agent for the Chickasaws by Van Buren and assisted in moving this Tribe to the country it now occupies. He remained agent in charge of this Tribe for ten years, at which time he came to Texas, settling in Washington County, which he afterward represented in the Texas Legislature two terms, and was a prominent citizen of the County until his death, which occured in 1877. His wife was Ann H. Crockett - a native of Williamson County, Tenn., but she is now a resident of Houston, Texas, and has reached the advanced age of 87 years. This lady was his second wife and became the mother of the subject of this sketch.

Under these impressions we have moved to and settled our lands and others of us have purchased land and exhausted our means to make homes where we might feel safe from the depredating savagies that formerly infested this delightful reagon(sic).

There were transactions in 1863 and 1864, and the last was on 22 September 1866 - G. A. Upshaw and wife to Whit Thomas; his wife signed as 'Mary A. Upshaw'.

He took an active part in public affairs, serving as Sheriff of the Parish for a period of seventeen years, at the end of that time resigning his office. In 1867, he moved to Red River Parish, and from there in 1872 came to Texas, settling in Bell County. He is now a resident of Belton, and has reached the advances age of seventy-four years. Both he and his wife are members of the Baptist Church.

The subject of our sketch was reared in Louisiana, and educated at Mount Lebanon University.

He was born in Macon, Miss., Nov. 22, 1844. He moved when four years old, with his parents, to Natchitoches Parish in Louisiana, where he grew to manhood. He enlisted at the beginning of the Civil War and was on March 27, 1862, assigned to Company H, ninth Louisiana Regiment Infantry, under Gen. Harry Hales and served until wounded at the Battle of the Wilderness in 1864, resulting in the loss of his right leg. During the war Upshaw joined the Baptist Church and was baptized by Gen. J. William Jones of Virginia, Chaplain of the army. After having lost his limb he was given a discharge and returned home.

In 1872 Upshaw came to Bell County, settling near where the town of Holland now stands. In April, 1876, he was chosen Clerk of the District Court, serving until elected County Clerk in 1878, in which office he served until voluntarily retiring in Movember, 1896. In 1906 he was elected county treasurer and has been re-elected every two years since - only once having an opponent. His family consists of Mrs. Upshaw, E. E. Upshaw, Miss Hattie, Miss Anna of Belton, Martin Upshaw of Teague and Lattimore Upshaw of Dallas.

Upshaw, well known in this section, has been associated with the affairs of Bell County longer than anyone living today, it is said.

Although a little stooped with the years, Upshaw is still active carrying on his work at his office in the courthouse. "I do all my work. Some days when I am rushed I call in some help to keep from getting behind," Upshaw said today. "Work will not hurt anyone."

When the Civil War was declared, Upshaw enlisted with the Confederate army. He served in the army for more than two years and was seriously wounded in battle, losing a foot while in action.

Several years later he was presented with a Cross of Honor at a general re-union of the Confederate soldiers held in New Orleans.

He served in the army for two and a half years. Several years later he was presented with a Cross of Honor at a general re-union of the Confederate soldiers held in New Orleans.

Funeral services will be held from the family residence Thursday afternoon at 3:30 o'clock with Dr. E. G. Townsend officiating. Interment will be in North Belton cemetery.
