LETTERS TO THE EDITOR

Dear Mr Brooke;

Dec. 22, 1975 Rockvale, Tenn.

First I want to compliment you on the wonderful job you are doing with the <u>Upshaw Family Journal</u>. It is just wonderful and I enjoy every word in it.

As I was reading Vol II #4, on page 108 I found the query about Adkins Upshaw, which is my family. Charity (Patton) Upshaw is my third great grandmother. She moved to Williamson County, Tennessee, in 1801 with her father and mother, James and Margaret (Wilson) Patton, from Elbert County, Georgia. She later married William Allison in 1808.

Concerning the estate settlement of Adkins Upshaw, I believe the administrator James Patton was the father of Charity, since her brother James would have been only 19 or 20 years of age at that time and I believe the Samuel Patton to be her uncle, since her brother Samuel would only have been 10 years of age at that time in 1800.

Now to the words "following T. Loveletty to Carolina"; what do you think this means? I have never been able to find the marriage of Charity Patton and Adkins Upshaw. They had only one child, Rebecca Upshaw, who married Rev. John King of Bedford County, Tennessee. In my research there, it is about a year or so from the time they sell their land in Burke County, North Carolina, until they buy land in Elbert County, Georgia. I have always thought perhaps they stopped off in South Carolina and since you mentioned the Drury and Peter Upshaw of Pendleton District, South Carolina, this makes me more positive than ever, since Rebecca (Upshaw) King's second son (my great grandfather) was named Robert Drury King. What else do you know about this Drury Upshaw?

I do hope you will be able to help me out with this. I will be glad to send you all the information on Rebecca Upshaw.

Thanking you in advance and I do wish you and your family a very merry Christmas.

Dear Sir;

I am most interested in tracing the ancestors of Sallie (Upshaw) Waring, daughter of John Upshaw who was born 24 July 1715 in Essex County, Virginia, and died there 23 July 1801. He was a member of the House of

Burgesses when Francis Waring was elected a member. (Colonial records in House of Burgesses).

The above Sallie (Upshaw) Waring was the third wife of Robert Payne Waring, who was born 13 Oct 1746 in Essex County, Virginia, and died there on 17 June 1799.

John Upshaw's wife was Mary Lafon, who was born 5 July 1744 in Essex County, Virginia, and died there in 1807; they married circa 1762. I note that this John and Mary (Lafon) Upshaw family was printed in UFJ, Vol II #4. I need notarized copies of the source of information of the birth, death, and marriage dates of John and Mary (Lafon) Upshaw, in order to properly complete my application to enter the Colonial Dames on this John Upshaw line.

Regarding Sallie Upshaw (1770-1828), my records only state that she married (first) Robert Payne Waring, son of Thomas Waring and grandson of Thomas Waring I, as his third wife and she married (second) "a in Versailles, Kentucky. This is from a family record that came from his descendants in Woodford County, Versailles, Kentucky. This Woodford County date or family record does definately state (with no source of reference) that William M. Bridges was the son of Sarah Bridges - not her husband; he executed deeds in Kentucky while a Virginia resident in 1833.

The objective of this program is to collect family group sheets from as many members of the Association as possible, especially concerning any families other than those listed in the inventory below. We are particularly in need of family group sheets of the more recent generations.

There are three blank family group sheet forms in this issue which I ask each member to fill out as completely as possible for their own family, their parents family, and for their grandparents family, or for any Upshaw family not listed in the inventory. Please do not be hesitant because your data may be sketchy or incomplete - simply securing the names and dates of the family members will provide a good framework on which to build further research and will help formulate the lineage of recent Upshaw descendants.
