THE EDITORS DESK



This issue contains some important new references to Upshaws in North and South Carolina. William and Thomas Upshaw have been located in Granville county, North Carolina, circa 1758-1762.

In South Carolina, we have discovered a Patience Upshaw on the Annuity Reports, circa 1791-1804, whom I believe to be the widow of William Upshaw who died in the siege of Charleston (see UFJ, Vol III, page 80). Several of the more unusual names on these reports are found in the 1790 census index of South Carolina, in the south part of Orangeburgh District (Benj. Odam, Reuben Roundtree, Ephrm. Sizemore, James Ward, and Joseph Youngblood), while several others are found in 96 District, Abbeville County (Andr. Pickens, Hezek. Posey, Joseph Reed, Henry Weems), so it seems likely that Patience Upshaw lived in one of those areas, probably in the household of a relative, as she is not found in the 1790 or 1800 census indexes.

Two deeds concerning Forrester Upshaw, circa 1805-1806, have been located in Anderson County (Pendleton District), South Carolina, which is adjacent on the east to Georgia and slightly northeast of Elbert County. The Editor has deed records of the Greenwood family which indicate that these families moved together from Elbert County to Pendleton District. You will note that a William Faulkner was the purchaser of one of the tracts from Forrester Upshaw (Book H, page 447) and that there is no record of Forrester having purchased this land, so the possibility exists that he may have received it as an inheritance through his wife Ann, who is believed to be a daughter of a William Faulkner. Although no Faulkner estate records have been found in Pendleton District which indicate the parentage of Ann (Faulkner) Upshaw, wife of Forrester, it is believed that a closer examination of the deed (and other) records is warranted.

We are thankful to Mrs. June B. Bork, Huntington Beach, California, who is researching the Burnett family, for locating in Lunenburg County, Virginia, the wills of Jeremiah Burnett and his wife, Mildred ("Milly") (Upshaw) Burnett, who was the sister of John and Leroy Upshaw, the early emigrants to Elbert County, Georgia. Their family group record sheet, although scant, appears in this issue; more information on their family, especially their children, will be appreciated. It is interesting to note that two of their children were named Leroy and Forrester!

Our Fall issue will contain Upshaw records of all non - Deep South states, except Missouri, from our files. Georgia records are being prepared for publication in volume V, 1978.

May our Lord keep each of us in good health, with His abundance of love and peace and joy in our lives.

Salute to Billie Bailey

Today we honor Billie Bailey, our oldest living member, who joined Westminister on January 12, 1923, as member #580. Billie will celebrate her 99th birthday on Saturday, January 29, having been born in 1878. Her address is 1706 N.E. 114th Avenue, where she receives excellent care from her landlady, Mrs. Teague.

Billie was born Doris Upshaw in Alabama 14 years after the Civil War ended. She was the daughter of a Baptist minister and received an excellent education at Judson College, Marion, Alabama. Later she met and married Luther R. Bailey, a student in architecture. They lived in the Boston area 5 years, where her husband graduated from MIT. In those happy years Billie was an avid student of literature and history. Boston was a wonderful city to indulge a patriotic nature. There their first son was born. Later the couple had another son and a daughter.

After the Bailey's came to Portland, Billie joined Westminister Church. She was an ardent worker in the Women's Association, dating back to Dr. Pence's days. For some time she was the Church Hostess in charge of dinners and luncheons, which meant obtaining much volunteer help. She assisted in the organization of a senior citizen's group at the Church. During the war she was very active in the group which sewed at Westminister for the Red Cross.

Mr. Bailey designed and had constructed many buildings along Sandy Blvd. Billie, a serious student and reader, felt a dire need for a branch library on the east side of the river. She was the motivating force in the establishment of the Rose City Park library near 44th and Sandy.

Billie was a charter member of the Robert E. Lee chapter of the United Daughters of the Confederacy and took an active part in this organization for many years.

She is brave, dignified and cheerful, and possesses a character above reproach. She exemplifies 99 years of a wonderful life of devotion, love and service to others and to her Church. Congratulations, Billie!

Willie Mae Upshaw Steward Kirby

Funeral services for Willie Mae Upshaw Steward Kirby were held at 2:00 p.m. May 19, 1977 at the Carmichael-Whatley Colonial Chapel in Pampa, Texas. She was born April 4, 1885 at Holland, Texas as the eldest child of John Allen Upshaw and his wife, Mary Alice Parker Upshaw.

Mr. Glen Walton, minister of Mary Ellen-Harvester Church of Christ, officiated. Burial was at Fairview Cemetery, Pampa, Texas.

Willie died at 2:00 p.m. at the home of her son, Max Kirby, of Walnut Creek, California, at the age of 92 after a brief illness.

When Willie was six years old, her father, John Allen Upshaw, died. Her two sisters, Lora Upshaw Vernen and Grace Upshaw Archer survive her. Her brother Fancher Upshaw, Sr. died in 1974.

Willie's mother's second husband was I. P. Vernon. They moved to a ranch south of Silverton, Texas in 1896. A half sister and half brothers of this union were Beuna, Jennings, Pete, and Cecil Vernon.

The family moved to John's Creek near Adobe Walls in Hutchinson County, Texas. Willie had met Will T. Steward at Silverton, Texas. Will went to Adobe Walls to marry Willie. Their marriage was performed by Billy Dixon, the famous Indian fighter, acting as Justice of the Peace on January 27, 1901.

Willie and Will Steward lived on the caprock at the present McKenzie Dam near Silverton, Texas. Three children were born to this union: Cassie, Weldon, and Wayland. Will was very ill for a year and died May 9, 1911.

Willie married John Kirby, who operated a country store near Silverton and Tulia, Texas. Their two children were two sons: Selmer and Max.

Two of Willie's sons preceded her in death: Wayland died in Amarillo, Texas in 1924 and Weldon died in Pampa, Texas in 1973.

Willie and John Kirby lived in Pampa, Texas and Amarillo, Texas until their later years when they moved to California and New York to live with their son, Max. In the 1950's they returned to Pampa to live until John's death in May, 1958. Willie lived alone until 1970 when she was no longer able to care for herself.

She was an excellent seamstress, a "stickler" for cleanliness, and extremely style conscious. In every sense of the word, she was a pioneer. Weldon, her first born son, was born in Elida, New Mexico, where she and her husband with his parents had homesteaded. They traveled from Silverton, Texas to Elida via covered wagon.

The Neglected Thread; A Journal from the Calhoun Community, 1836-1842. Diary of Mary Moragne' Davis, wife of Rev. William Hervey Davis. (contributed by Mrs. Charlotte D. Parrott).

Mrs. Davis lived until she was almost sixty (60) years old, in the area of South Carolina including the present Abbeville and McCormick Counties and part of Greenwood County, which lies along the Savannah River about 40 miles upstream from Augusta, Georgia.

The Calhoun's had been among the first to come into this region (1756) eight years before the Huguenots arrived. The settlement for the Huguenots was New Bordeaux, 3 1/2 miles from the Savannah River. Willington, also close to the Savannah River, was the site of Rev. Moses Waddel's Academy - people moved there to educate their children and remained permanently, and led to the organization of a Presbyterian Church in 1813. Rev. Waddell's successor was Rev. William Hervey Davis. who married Mary Moragne in 1842. This Church was eight miles from Hopewell and was the oldest church in the region. It was at Hopewell that the Calhouns had worshipped in Colonial days when the Rev. John Harris, it's earliest Pastor, preached with a powder horn around his neck and his gun by his side in the pulpit (George Howe's <u>History of</u> the <u>Presbyterian Church in South Carolina</u>, 1870). The Moragne children spent much time with their mother's relatives at Willington and Cambridge. 1 (1 Background, page xv)

(page 37). 12 Friday 1837 - I was reading this morning when I heard a strange voice below stairs, informing my mother that Mrs. Upshai(sic) and Mrs. Thompson, two ladies from Elbert (County), Georgia, would dine with us today. This was a strange announcement certainly, as we had never seen either of the ladies, but I was pleased to hear it, as I had a curiosity to see Mrs. Upshai, who had frequently been down to her plantation here. Accordingly, about

11 o'clock they came. I was surprised; first to find Mrs. Upshai so good looking and next to find her so pleasant. I love to find my way to the heart of a new acquaintance and besides, I had a particular desire to please Mrs. Upshai, but I employed no means but the natural promptings of my heart, and we were soon on intimate terms. I observed with a sort of curious pleasure, that when she first addressed me it was with "Miss Moragne'", then "Miss Mary" — but before the dinner hour she called me Mary. The other lady was a plain neat woman dressed in black. I didn't know until she had left that she was the widow of the Indian agent who was killed by Oseola, at Columbus.

(page 121). 1839, 21st Sunday - In the evening before mother had returned (from church at Willington to hear Mr. Davis preach), a handsome young man came in, whom we recognized as James Upshai(sic), the heir of the plantation of that name below us. Having come on a visit to his father's plantation he had called to see me as he remembered seeing me two years ago at Dr. Richardson's in Elbert, Georgia. This gallant and handsome youth, with a little more polish, would be very interesting. I was very pleased with his naivete, and that freshness of feeling which belongs to the young and unhackeyed. I was sorry that I had not a copy of the Partisan to give him, as he declared that he knew of but one copy in Elbert, and that had yet to go through some six or eight hands before he could obtain it. In coming to Carolina he had expected that favor from me, he said ...

A short time since I received your letter of the 6th Nov. respecting the Catawba Indians and their wish to live with the Chickasaws. Since it's reception I have seen several of the principal man of the Chickasaws and they all appear willing to take them, but the letter must be read in Council which will be in next month. At the payment of the second half of the annuity of 1848, I have no doubt but what all the Chickasaws will agree to take the Catawbas, I shall do all I can to carry out the wishes of the Government on the subject. So soon as the Chickasaws decide to take them, I will give you my opinion which will be the best route for them to emigrate by. Agreeable to your regard.





Burnett

Miscellaneous Burnett family notes; contributed by Mrs. June Bork, Huntington Beach, California, 1976.

Jeremiah Burnett, husband of Mildred Upshaw, died in Lunenburg County, Virginia, in 1812 when his will is recorded. The deed records have been searched up to 1825 and Mildred was alive at that time (see DB 26, pg 459) in Lunenburg County. I have no further record of her, but I am sure she probably died there (see Mildred Burnett will, Lunenburg County Will Book 11, pages 338,339). I have made no connection between the Patrick County, Virginia, and Wayne County, Kentucky, Burnetts with the Lunenburg group. I do know that of Jeremiah Burnett of Lunenburg, his cousins went to Spartanburg County, South Carolina, where the Hurts were. These Hurts did settle in Wayne County, Kentucky. Jeremiah Lived in Mecklenburg County, Virginia, before moving to Lunenburg County, so there may be a marriage record there of him to Mildred Upshaw.

Jeremiah Burnett was a son of Joseph Burnett who died in 1771 in Essex County, Virginia, giving him a number of slaves. Joseph Burnett died intestate and his son, Richard, was the administrator. Joseph had land in Essex, Caroline, and Dinwiddie counties and had sold land in Amelia in 1762 to David Eubanks. Joseph's estate was not settled until 1784, some 11 years after he died. His widow, Clara (Gatewood) was still living at this time. His children were: Jeremiah, who married Mildred Upshaw; Joseph (no further record); Thomas; Rachel Burnett, who married Benjamin Gatewood; Clara Burnett, who married John or Henry Gatewood; Leonard, who married Amy Gatewood; and Richard, who married Mary Baughan.

Concerning the Burnett-Hurt family connections, we find that a John Burnett married Mary H. Hurt on 22 November 1821 in Lunenburg County, Virginia; bondsman was Allen Hurt.

I lend to my daughter Catharine Murrell for and during her natural life the house she now lives in together with twenty five acres of Land to be laid off as convenent to the said house as possible & at the death of my said daughter my Will and desire is that the said twenty five acres of land return and be annexed to the Track of land to which it now belongs. I also lend to my said daughter Catharine two negroes named Isaac and Lucy for and during her life & at her death I give and bequeath the said Isaac & Lucy with their increase to her two daughters Melissa Murrell & Narcissa Murrell but should either of the said daughters die without a child or children lawfully begotten living at the time of her death then & in that case it is my Will &desire that her proportion of the two negroes last aforesaid together with their increase be equally divided between Fielding Burnett & Matilda Burnett. I give & bequeath to my daughter Joanna Davis the following negroes (to wit) Abram Franky, Pat, Anthony and Fanny with their increase also one mare bridle & saddle one cow & calf one sow & pigs & one bed & furniture which property has been Delivered. I give to my daughter Matilda Burnett the following negroes to wit little Harry Lewis Silvia Avory Rachel and two beds & furniture one horse bridle & Saddle one cow & calf but if the said Matilda should die without having at the time of her death a child or children lawfully begotton then and in that Case the said property to be divided equally between my Daughter Joanna Davis & Judith Burnett. I will & desire that at my death the half of my stock not herein abefore bequeathed to my wife be equally divided among Forrester Burnett, Spencer Burnett, Fielding Burnett, Judith Burnett & Matilda Burnett. Lastly I nominate & appoint my son in law William Davis & my Friend John Brichett Exors. of this my last will and Testament. Signed, Sealed & Published this 18th day of December 1812.
