Our devoted charter member, Mrs. Grace E. Jared, nee Grace E. Heminger, died Saturday, March 11, 1978, at her home in Olney, Illinois. Memorial services were held on March 14, 1978, in the Memorial Chapel of the Summers Funeral Home, the Rev. R. E. Dowden officiating. Interment was at Haven Hill Cemetery in Olney. Casket bearers were Jared Johnson, Lynwood Johnson, James Poole, Jr., Brian Jared, Alan Jared, and Jay Mack Jared.

Mrs. Jared was the daughter of Adam P. Heminger and Josephine Eva Upshaw. She was born on 23 May 1888 in Piatt County, Illinois, the youngest of three children. She and Mr. Ray V. Jared were married on 28 June 1910 at her parent's farm home in Douglas County, Illinois. They were the parents of three children: Mildred Josephine Jared, Milfrieda Louella Jared, and Leland Heminger Jared; in addition to an adopted daughter (her niece), Eula May Gaddis.

"Cousin Grace", as she is known to us, was selected for inclusion in the Dictionary of International Biography, Cambridge, England, volume XI, 1974 edition. She had already been named in "World Who's Who Women" (London) of seven thousand women as authors. She also holds a certificate of selection in "Who's Who in American Women" and her biography given in Eighth Edition as author and business woman.

Mrs Jared was the first woman in Illinois to found a baby chick hatchery and had agriculture interests in three Central Illinois Counties. She had a lifetime experience in commercial writing, AP reporting, writer of civic and political interest, editorials and articles in many newspapers. She wrote a monthly column for eleven years on advertising and business.

She was a member of the Stephen A. Douglas Chapter D. A. R. and George Rodgers Clark Chapter Daughters of American Colonists.

Her book They Met Challenges ... With Memoirs was written in 1968 and included a section on her Upshaw genealogy which she was kind enough to share with us and allow to be reprinted in the Upshaw Family Journal.

I was never priviledged to meet her personally but through our correspondence over several years, I developed a great respect and admiration for her. The membership of the Upshaw Family Association of America offers our condolence to her family.

Our dear charter member, Mrs. Preston C. Upshaw, nee Sophie Daves Wright, died Sunday, 16 April 1978, in Atlanta, Georgia. Interment services were held on Tuesday, 18 April, at Arlington Memorial Park in Sandy Springs, a suburban community north of Atlanta. Dr. George McMaster officiating. Contributions may be made to the library fund of First Presbyterian Church, Atlanta, Georgia, or to the Georgia Heart Association.

Mrs. Upshaw was born on 25 March 1904 in Milledgeville, Georgia, but lived most of her life in Atlanta. She was the youngest of five children, the daughter of Rev. Joel T. Daves, D. D., and Sophie Pauline Wright. She and Mr. Preston Carl Upshaw were married on 20 January 1927 at her home on the Prado in Ansley Park, Atlanta, Georgia. They were the parents of three children: Anne Upshaw, Preston Carl Upshaw, Jr., and Allen Wright Upshaw.

She was a member of the Junior League and headed the Cator Woolford Garden at the Cerebral Palsy Center. She established the library at the First Presbyterian Church and was active in the Atlanta Speech School.

In 1975, she authored <u>Captain William Upshaw</u>, <u>Gent.</u>, <u>Planter</u>, <u>of Virginia</u> (<u>Gateway Press</u>, <u>Baltimore</u>) which contains her husbands' <u>Upshaw genealogy from William Upshaw</u>, through Capt. Forrest Upshaw, Leroy Upshaw, Forrester Upshaw, Forrest Tinsley Upshaw, Preston Calhoun Upshaw, to Preston Carl Upshaw.

I was never priviledged to meet her personally but we spoke by telephone on many occasions and I had great admiration for her. I last spoke with her in March when she was quite pleased to hear of recent major progress we have made concerning Upshaw genealogy. In spite of still recovering from a severe illness herself, she was not concerned about her own state, but asked about myself and my family. She was a gracious lady and she will be missed.

THE EDITORS DESK



I have postponed the miscellaneous Georgia county records originally planned for this issue and have continued with Georgia Upshaw records of a general or state-wide nature in order to conclude that area of our research. I also wanted to present as soon as possible the information on the allied family of Staples which reveals that Elizabeth ("Betsey") Upshaw, wife of John Staples, was a daughter of Leroy Upshaw and also reveals much of her and her family. Especially noteworthy is that her birthdate was 1 December 1770, which means that Forrester was born no earlier than circa 1772 (unless he was her twin, which is very unlikely). Elizabeth's marriage to John Staples on 19 December 1786 in Buckingham County, Virginia, means that in all likelihood her father, Leroy Upshaw, was still in Buckingham as of that date and not yet come to Georgia. John and Elizabeth (Upshaw) Staples lived in Burke County, North Carolina, from 1805 to circa 1816, but the Burke County courthouse was unfortunately destroyed by fire in 1865 and all records were lost. We do have the 1810 census enumeration of them and I understand there are some 1200 original marriage bonds of Burke County in the Archives in Raleigh which may have some Staples marriage references. The Morgan County, Tennessee, records need to be searched to document as many marriages of their children as possible, etc., as well as for any references to any Upshaw relatives who may have been there with them.

I believe it is extremely important to note that this startling new Upshaw family information was derived by search of the military records and pensions files in the National Archives. We have suspected for some time that John Staples was connected with the Upshaw family, due to his land being near them in Elbert County, his obvious interaction with them in various legal instruments, as well as the fact that his oldest son was named Leroy Staples, which was Elizabeth's father's name. But without the proof found in the Revolutionary War pension file, we could probably never have positively established and verified this connection. I am saying all this to emphasize that even today, after the many years, literally decades, already spent searching by diligent researchers, there are new and unsearched sources which can yield bountiful results, and the John Staples case is one example.

Another example which will be featured in our next issue is that of George C. Greenwood, who married Martha Upshaw, daughter of Leroy and Elizabeth (Bradley) Upshaw, and moved to Franklin County, Illinois, where she drew a pension for his service in the War of 1812.





#27 COOK ERWIN HAM HARDEMAN NILES PATRICK RUCKER UPSHAW

James UPSHAW was born and raised in Elbert County, Georgia, being the son of John UPSHAW (1755-1834). His wife was Lucendie HAM and they had twelve children, two sons and ten daughters. About 1836, when James was already 47 years old, he and his family moved from Elbert County to Cass (now Bartow) County. There must have been compelling reasons for a man of that age to move from a County he had lived in all of his life into a new home, virtually in the wilderness. This is puzzling enough, but the most baffling part of this story is that he did not take three of his children with him, but sent Clara UPSHAW (b ca 1821; PATRICK), Caroline UPSHAW (b ca 1823; md ERWIN), and Mildred UPSHAW (b ca 1827; md NILES) to live in Dooly County, Georgia.

Family tradition has indicated that they went to live with relatives, but I have never been able to trace them further. I have presumed that, going into the wilderness with only two sons (John James UPSHAW, b 1814 and Thomas S. UPSHAW, b 1825). James and Lucendie must have feared that they might not be able to feed their family of 14 people and so took the extraordinary step of sending three of the girls to live with relatives already established in Dooly County.

In the Upshaw Family Journal, Vol V, no. 1, (January 1978), page 14, is the record of the orphans of John UPSHAW (1776-1818), who married Rebeccah COOK in 1794. Their two orphans were Elizabeth Burch UPSHAW and Middleton Cook UPSHAW, who married Elizabeth RUCKER in Elbert County in 1830. Their land in the 1821 Land Lottery was granted to them in November 1825 in Henry Co.

It is improbable that Middleton Cook UPSHAW moved to Dooly County after his marriage in 1830 (Editor's note: I have his tombstone record in Elbert County, where he died in 1838). Could Elizabeth Burch (UPSHAW) HARDEMAN have moved there and had three of her uncle's daughter's come live with her, remembering that John UPSHAW, Jr., and James UPSHAW were brothers. If not. does anyone know what relatives James UPSHAW may have had in Dooly County?



CORRECTION CORNER

Under the 1840 Georgia census index as presented in UFJ, Vol I, page 57, the Editor made a statement that the reference to Peter Upshaw in 1840 Dade County, Georgia, was incorrect and that the spelling was actually Peter Upham. After very careful study of the handwriting on this census, I have ascertained that this spelling is Uphaw, and I now know from the number and ages of the household members that this is definately Peter Upshaw, who died in 1841 in Natchitoches Parish, Louisiana. This spelling discrepancy occurred, I suppose. because the "s" in Upshaw got "lost" somewhere between the census taker's ear and the end of his pen. Luckily, there is also a deed from Peter Upshaw, made in Dade County 19 Sep 1840 (Deed Book D, page 339).

□ BOOKS □

The Upshaws ... Our Story; by Mary Imogene Noble Carpenter, (no place, no date), hardbound, 100 pp; available for \$20.00, postpaid, from Mrs. R. A. Carpenter, 403 E. Parker, Hamburg, Ark., 71646.

This short volume fills a gap in the Louisiana and Arkansas branches of the Upshaw family which has been sadly neglected until now. This book deals primarily with the descendants of Richard and Rebecca (Elder) Upshaw, who were married in 1820, Elbert County, Georgia.

Although the book contains no table of contents and is not indexed, most of it is arranged by families: the family of E. D. Upshaw is on pages 36-67; the family of Ira Upshaw is on pages 68-75; the family of Will Upshaw is on pages 76-94; and the family of Jim Upshaw is on page 95.

As in many cases, the copies of courthouse documents and other items carefully selected by the author to appear in the book did not reproduce well and their value was thus lost. Despite this and other shortcomings, this book will doubtless be treasured by those whose families are detailed in it and is a valuable guide for Upshaw researchers to the various Upshaw families in Louisiana.

I don't believe that anyone who has never written a book can truly appreciate the tremendous effort that is required with a genealogical book. It is long evening and night hours, endless letter writing, lack of cooperation by many, the financial costs, and everything else which contribute toward making it sometimes seem like a thankless effort. Mrs. Carpenter is to be commended for her unselfish effort.

Douglasville, Ga., Sept. 9 - Mr. L. C. Upshaw, brother and secretary to Congressman W. D. Upshaw, died at 2:30 o'clock Wednesday afternoon in Washington, D. C., after a protracted illness. Mr. Upshaw had lived in Washington for a little more than two years.

He was an old citizen of this place, having lived here for more than thirty years, and was a member of the mercantile firm of Upshaw Brothers. He was a former mayor of Douglasville, and represented Douglas County two terms in the Georgia legislature. He was well known, popular, and always took considerable interest in the politics of his county and state.

He is survived by his wife, Mrs. Rosa Smith Upshaw; one son and three daughters, L. C. Upshaw, Jr.; Misses Marion, Louise and Carolyn Upshaw, of Douglasville, Ga.; Mrs. G. B. Lindsey, College Park, Ga., and Congressman W. D. Upshaw, of the Fifth District.

The remains will reach Douglasville Friday and the funeral and interment will take place here at 9 o'clock Saturday morning.

Upshaw "Favorite Son" of Douglas County in 1932 Presidential Race (By Harris Dalton)

Memories of William David Upshaw are growing dim but the philosophy of the prohibitionist who carried Douglas County in the 1932 Presidential campaign is still firmly rooted in the soil where he once gave fiery speeches against alcohol. No one remembers how many votes Upshaw garnered in that famous election which pitted Franklin D. Roosevelt against Herbert Hoover but Frank Winn remembers that Upshaw carried the day in Douglas County.

The staunch prohibitionist didn't do so well state-wide, however. Records show that he collected only 1,125 votes in his home state and 80,000 throughout the nation.

But despite his failure in the Presidential election, Upshaw continues to be a factor in the lives of Douglas Countians who knew him.

One Douglas County lady remembers signing a pledge which Upshaw passed out after all of his prohibition speeches. It stated that the signer agreed never to touch alcohol during his or her lifetime.

This particular lady says that she has until yet to break her pledge. Another lady remembers that "Willie D" used to make speeches at the Douglasville High School and would shout, "Lips that touch liquor shall never touch mine."

After this he would say, "All you young ladies who agree with this, stand up." It is reported that all the ladies of that era rose in unison.

As far as it can be determined, William David Upshaw never lived in Douglasville, but he was a "favorite son" and visited his two brothers here quite often and was held in high esteem for his temperance work.

One of the brothers, Herschel Upshaw, lived on Bowden Street where the A. A. Bennetts now reside. Another brother, Lucius, lived at the corner of Highway 78 and Highway 5. That house has been torn down for several years.

The two Upshaw brothers operated a large "general store" in Douglasville for many years after coming to Douglas County from Powder Springs.

William David Upshaw was born October 15, 1866 in Coweta County. The family later moved to a farm in Cobb County near Powder Springs.

It was at Powder Springs that 18-year-old Willie D. Upshaw fell from a wagon while working. The accident kept the young man confined to bed for seven years and made him a cripple for life.

"Millie D." hobbling around a church yard on crutches was a familiar sight to Douglas Countians.

During the confinement of his accident, Willie D. became interested in writing and wrote a regular column called "Earnest Willie" for a newspaper of the day.

Later "Willie D." widened his literary world and wrote a book, "Earnest Willie or Echoes from a Recluse."

It was a masterpiece of flowery language with "Willie D." proclaiming he was suffering from "ennui" and that being unable to write the book himself, he dictated it to an "amanuensis."

But, apparently the people liked it. The book ran 11 editions and the money earned from the sales provided "Willie D." with the means of getting a college education.

In the book "Willie D." paraphased another "Willie," William Shakespeare by saying "To be, and what to be: that is the question."

"I know one thing," Willie D. said, "I mean to be something and the best way to be something, is to do something."

"I have often felt that I would like to be a statesman ..." he cogitated, but pointed out that a "deficit of brains" would never let him be a statesman.

But "Villie D." didn't let this stand in his way long. With the support of the Temperance Leagues, he was elected to the Sixty-sixth Congress from the Fifth District of Georgia, securing 12 of 16 county-unit votes over six opponents.

In taking such a strong stand against alcohol, "Willie D." was bound to stir up enemies. One resident recalls, "He was a controversial man of his time. The feeling about him was very much like the current feeling of Lester Maddox. He had his strong supporters and his bitter enemies."

But "Willie D." didn't let his enemies dampen his prohibitionist views. In his book he pointed out that the one thing he would never be was a saloon keeper.

The author of the book said that saloon keepers were contributing to the fall of the weak father and the husband. Always interested in helping struggling boys and girls, Upshaw gave seven years without pay to this work at Mercer University and Bessie Tift College in Forsyth.

He founded the "Golden Age," an undenominational magazine; was vice president of the Georgia Anti-Saloon League and active in the fight against saloons that made Georgia a prohibition state in 1907.

He spoke widely under the auspices of the Anti-Saloon League and the Women's Christian Temperance Union. In addition to being elected to Congress, and running unsuccessfully for president, he was also thwarted in his bid for Richard Russell's Senatorial seat.

Upshaw lived to be 86 years old and was active until the end when he died on November 21, 1952 in California where he had moved during the last years of his life.

The fiery prohibitionist candidate for president in 1932 died of a heart condition in a Glendale, California sanitarium with his second wife at his bedside.

A report in the Atlanta Constitution of November 22, 1952 stated, "Entering the hospital two weeks ago after a speaking tour of 22 states and seven European Countries Mr. Upshaw gradually slipped into a coma. Physicians said the tour seriously taxed his health.

"His death marked the end of a stormy political career, begun when he ran for Congress as an opponent to the liquor interests in Georgia. He was an ardent supporter of Rep. Andrew Volstead and the 18th Amendment."

The story about "Willie D.'s" injury took two paths after telling and re-telling. In his book, Upshaw said that he fell from a wagon. Later the story was that he was permanently injured in a fall from a mule.

Going along with the newer version "Earnest Willie" frequently told his temperance audiences, "That mule kicked the devil out of me and the fear of God into me," according to a report in the Atlanta Constitution.

The obituary notice said, "Handicapped as he was, he published his "Earnest Willie, or Echoes from a Recluse," a book which ran 11 editions and furnished the money with which he later attended Mercer University.

Elected to Congress in 1918 on a prohibition platform, Mr. Upshaw was the only Georgia representative voting for the 19th (Women Suffrage) Amendment. He also was instrumental in obtaining a pay increase for postal workers.

In 1928, he was one of the many Georgia supporters of Herbert Hoover, speaking actively in his behalf on frequent occasions.

He broke completely with the Democratic party in 1932, stating that "Republican liquor and Democratic liquor both came out of the same jug." As prohibitionist candidate for president he polled 80,000 votes.

Willie Upshaw's last visit to Georgia was in August, 1951 on the 67th

Willie Upshaw's last visit to Georgia was in August, 1951 on the 67th anniversary of his baptism in Powder Springs Creek in Cobb County. He was ordained a Baptist minister at the age of 72.

In 1942, Upshaw waged a losing battle for the U. S. Senate against Richard Russell, saying, "Georgia has been good to the Russell family. It's about time the Russell family started being good to Georgia." He received 55,846 votes in his losing battle.

At a faith meeting in January of 1952, Upshaw threw away the crutches on which he had walked for 59 years. There are some who recalled that he would also abandon the crutches if he needed to hurry to catch a train.

He began a Bible school in Santiago, Calif., at the age of 80 and lectured widely on the evils of drink and sin to church and temperance societies.

During his campaign for Congress, he spoke at the Atlanta Municipal Auditorium. He leaned on his crutches and looked at his audience until there was absolute quiet. Finally he opened with this question: "Have you folks heard about the new bill that's going to be introduced into Congress? That bill is Bill Upshaw ..."

Funeral services for William D. Upshaw were held at the World Church in Los Angeles with buriel in Forest Lawn Cemetery in California.

The body of the noted congressman was not brought back to Georgia for interment because of the feeble condition of his widow.

It seems strange that William David Upshaw was not returned to his native Georgia soil, because it is here where his philosophy still lives.

As a footnote, it might be pointed out that Upshaw finished fifth in the seven man Presidential election. Roosevelt took the election with 22,809,638 votes with Hoover second with 15,758,901. Thomas, running on the Socialist ticket, garnered 881,951 votes and Foster, a Communist, was fourth with 102,785. Upshaw was next with 80,000 and Harvey of the Liberty Party sixth with 53,425 and Reynolds, representing Socialist Labor, seventh with 33,276.

But this was the closest a man with Douglas County ties has ever come to the White House.

- I) Statement: Certificate no. 4499; Tennessee, Knoxville. Betsey Staples, widow of John Staples, who served in the Revolutionary War, Col. Davies, Va., as a private, increased from \$40.00 per annum; inscribed on the roll at the rate of \$96.00 per annum, to commence on 1 July 1848. Certificate of Pension issued 2 September 1851; recorded on roll of pensioners under act of February 2, 1848, page 306. vol 3.
- II) Declaration: In order to obtain the benefit of the act of Congress of the 7th July 1838 entitled an act granting half pay and pensions to certain widows.

Personally appeared before me Thomas Jack a Justice of the Peace for said County. Betsey Staples, a resident citizen of Morgan County, state of Tennessee, aged 68 years the first day of December next according to her record in her Bible who being first duly sworn according to law doth on her oath make the following declaration in order to obtain the benefit of the act of Congress passed the 7th July 1838, entitled an act granting half pay and pensions to certain widows.

That she is the widow of John Staples who was a soldier in the war of the Revolution and a Revolutionary pensioner of the United States and was enrolled for payment at Knoxville in East Tennessee.

She further declares that she was married to the said John Staples on the 19th day of December 1786 agreeable to her record in her Bible. She was married to her said husband in Buckingham County in the State of Virginia; that her said marriage was solemnized by a Methodist preacher named Green, his first name she does not recollect. She states that her said husband was a good hand to write until he became too old, that her record of the family as put down in her Bible is in the handwriting of her said husband, that she has cut out the leaf of a record in her said husbands handwriting out of the Virginia Lawbook called Henning's Justice that her said husband brought from Virginia, which contains the true record of her said marriage and the ages of her children, that her said husband wrote the same, except where a few letters had sometime past become so dim that her son put the ink in the old marks, and the same is more deep in black ink. She further states that her said husband the said John Staples died on the 28th day of June 1837 in Morgan County, State of Tennessee; he died of some stomac(sic) affliction and old age, his affliction resembled consumption, that she was not married to him prior to his leaving the service, but the marriage took place previous to the first day of January 1794, to wit, on the 19th day of December 1786, the time she has stated. She further states she has been confined to her bed for many months with some affliction of the limbs of the rheumatic order and is entirely unable to attend court to transact business, that she has remained a widow ever since her said husband's death.

She further states that she was married to the said John Staples in Buckingham County, Virginia by Greenberry Greene a Methodist preacher on the 19th day of Decr. A.D., 1786 and that her name before her said marriage was Betsy Upshaw. That her said husband died on the 28th day of June A.D. 1838 and that she is now a widow.

She makes this declaration for the purpose of obtaining the Bounty land to which she may be entitled under the act of Congress approved 3rd day of March A.D. 1855 and all other acts. She further declares that she has not received any Bounty Land under any other act of Congress.

Reference is made to your letter in which you request the Revolutionary War record of John Staples of Virginia.

The data furnished herein were obtained from papers in pension and bounty land claims on file under W.22, based upon service of John Staples in the Revolutionary War.

John Staples was born September 14, 1757, in Albemarle County, Virginia and was reared there. Names of his parents are not shown.

He enlisted February 14, 1778, served as private in Captain P. Jones' company, Colonel William Davies' Virginia regiment and was discharged February 18, 1779.

The soldier was allowed pension on his application executed July 20, 1818, while a resident of Morgan County, Tennessee. He died there, June 28, 1837.

John Staples married December 19, 1786, in Buckingham County, Virginia, Betsey Upsher or Upshaw, who was born December 1, 1770. Place of her birth and names of her parents are not shown.

Betsey Staples was allowed pension on account of the services of her husband, John Staples, on her application executed October 3, 1838, while a

resident of Morgan County, Tennessee.

November 4, 1855, while still a resident of Morgan County, Tennessee, Betsey Staples made application for the bounty land which was due on account of the service of her husband, John Staples, in the Revolutionary War. She was granted one hundred sixty acres of bounty land on Warrant No. 61340, under the Act of March 3, 1855.

Betsey Staples died August 24, 1858.

In 1820, the soldier stated that the following children were living with him: Nancy, William, Betsey, Thomas, Caroline, Clarisy, Christian, Salley, and Taliafro, aged respectively, twenty-two, eighteen, sixteen, twelve. eleven, ten, eight, six, and two years.

In 1838, William D. Fields was referred to as a son-in-law; the name of his wife is not stated.

In 1838, one Kesiah C. Butler made affidavit in Anderson County, Tennessee, and stated that her mother and John Staples, the soldier, "were own cousins". She did not give her mother's name.

In 1855, one B. T. Staples was acting Justice of the Peace for Morgan County, Tennessee, no relationship to the family was shown.

In order to obtain information in regard to the location of the land cited above, you should address the Commissioner of the General Land Office, Interior Department, this city, and furnish the warrant number, the acreage. and the act under which said warrant was issued.

Deed Abstracts 1791_1817:

These are abstracts of all deed items in Elbert County which involve John Staples.

These abstractions reveal some important information:

- 1) In the second deed made by John Staples, 30 Jan 1793 (DB M, pg 106) he sold land to John Booth "of Buckingham County, Virginia", which was probably an acquaintance of his there, before coming to Georgia. Also, this deed names "Betsey" as his wife, and "Elizabeth" is found in the deed in Book K, page 174.
- 2) Throughout most of these deeds, it is seen that his land was situated in the Doves Creek area, in the vicinity of John Upshaw, Larkin Gatewood, and William Bradley.

3) In his deed to Zechariah Faulkner, dated 9 Dec 1800, two of the witnesses were Forristor(sic) Upshaw and William Faulkner.

4) In the last deed he made in Elbert County, dated 1 June 1805, he stated then that he was already of "Burke County, North Carolina", indicating that he and his family had moved there between 6 Jan 1804 and 1 Jun 1805 and they are found there in the 1810 census. We may note that John Staples was still in Elbert County, perhaps concluding his own affairs there, as well as acting as one of the executors of William Bradley, when he gave oath at the registration of the will of William Bradley on 26 Sep 1805; the earliest reference to him was when he signed as a witness to a deed dated 6 Jan 1790 (DB A, page 62).

We may conclude from these abstractions that John Staples lived in Elbert County, Georgia, from 1790 to 1805, which means that his children

Staples Family History (1 page); (submitted by Elsie S. Burkett):

The Staples family came to America from England and first settled on land along the James River in Virginia. The father and five sons of the Virginia family all fought in the Revolutionary War. The one who came to this area in Tennessee was John, who married Betsey Upshire(sic) in Buckingham County, Virginia, in 1786. Until 1816 they had lived in Burke County, North Carolina, where all of the fifteen children had been born but one, Benjamin T., born 1817. (Editor's note: The writer of this history was evidently unaware that John Staples had lived in Elbert County, Georgia, from 1790 to 1805). They lived in Morgan County after it became a county seperate from Roane. John was a trader, dealing mainly in cattle, land, and timber. In 1826 he was appointed by the State as a Trustee of the old Montgomery Academy.

The son that moved into the Rockwood area was Thomas, whose first wife was Catherine Long; and second, Permelia Van Winkle. (etc.)

Capt. Thomas Staples' descendants still in or near Rockevans and children (Editor's note: evidently a line of type was omitted by the printer in the previous sentence, as it is not sensible), and Mrs. Elsie Staples Burkett. Among other descendants of the Revolutionary John Staples living here are Mrs. Allen Montgomery and daughter, Ellen; John Evans, Mrs. Betsy Evans Broyles and Tom Evans and children; Mrs. Rolland Regester and Mr. W. C. Weatherford.
