THE EDITORS DESK



Welcome to the belated October 1978 issue of the <u>UPSHAW FAMILY JOURNAL</u>. Our printing schedule has fallen behind due to increased church, family, and job responsibilities and the vol IV and vol V indexes are not yet prepared, as I'd hoped they would be. I appreciate your patience and understanding and am thankful for your forbearance in this regard.

In order to bring our printing schedule to current dates, I've made the decision that vol VI of the UFJ (1979) will be issued as one edition, rather than four quarterlies. This annual edition will, of course, be 100+pages and will include a broad range of Upshaw records from all states. By moving from a quarterly to an annual edition, I will save much time in trips to the printer, post office, etc., which will make my job much easier and will aid me in restoring our schedule. I plan for vol VI to be available by early summer, 1979.

While our printing schedule has fallen behind, Upshaw research has been continuing and there are several important developments.

Mrs Mildred (Jared) Johnson, daughter of our late cousin, Mrs. Grace E. Jared, has been kind enough to deposit with us all of Mrs. Jared's Upshaw files for research and preservation. In addition to several books, there are approximatly two cubic feet of letters and correspondence, newspaper items, copies of various documents, and etc., which she had accumulated in the 40 years she researched the Upshaw family. I have perused the voluminuous files and developed a filing and indexing system for them which will both organize and protect them, as well as reveal their genealogical content for the aid of researchers. Several 3-ring binders and several hundred sheet protectors will be purchased to house the "Grace E. Jared collection".

\$400 has been contributed thusfar for the Upshaw immigrant research and I am contracting to have this work begun. This report will be shared in the UFJ with the members and we are all thankful for the generosity of several persons who contributed to make this project possible.

There has been no response in regard to the chairmanship of a possible Upshaw Reunion, although several additional members have expressed interest in attending such a reunion. If anyone would like to volunteer to organize an Upshaw Family Reunion, I will cooperate in every way possible, including utilization of the UFJ in promoting and advertising the reunion.

The first seperate "Allied Family" publication has been issued - it is Routon Family Records, vol I, 41 pages, available for \$7.50 postpaid. The Upshaw connection is in Carroll Co., Ga., where Mary Catherine (Hay) Routon married Adkin Upshaw in 1867 and where her daughter, Ida Pope Routon, married Adkin's son, Robinson Valentine Upshaw.

Thank you all again for your kind patience.



Mary Addison Woolum Thevenet, the compiler of this well arranged, well documented family history, is a member of the daughters of the American Revolution; the United Daughters of the war of 1812, John Cavet Chapter; A Real Daughter of the United Daughters of the Confederacy; and a member of the Colonial Dames of the 17th Century. Through her father, Henry Addison Woolum and her grandmother Elizabeth Jones Harwood Woolum, she is the 13th generation in america on the Harwood family; the 9th generation in america on the Roane family; the 8th generation in america on the Upshaw family. The line of descent is given for these families. Each of the following chapters in the book begins with the earliest documented ancestor of the family:

Thevenet; Woolum; Vaughan-Forrest-Berry; Harwood; Upshaw; Roane; and Bell-Pitner-Davidson.

The numbering system clearly identifies the relationships between the ancestors and descendants. Background information and important documents introduce each chapter. Of special interest is the history of

La Reunion Colony of Dallas County, Texas. Michel Thevenet and his family were pioneer settlers of the colony. The book also contains a full name index, photographs, and other illustrations.

Upshaw, Cobb County, Georgia,

Located on Wild Horse Creek, eight and one-half miles southwest of Marietta, three miles from Powder Springs, it's railroad depot, telegraph and express office, via which it was 22 miles from Atlanta, with a population of 90, a Baptist Church and a Methodist Church, and public school.

Mail was by special supply, with Isaac D. Upshaw serving as Post Master, and he also operated a general store, was a blacksmith and shoool teacher.

- B. V. T. Hubbard was a millwright
- A. J. McCurdy was a millwright
- B. N. McEachern was Notary

John Gresham was born in Virginia on January 24, 1759. He died in Oglethorpe Co., Ga., Sept. 19, 1818. He married Martha W. Scott on Feb 13, 1794. She was the daughter of John and Elizabeth (Upshaw) Scott.

John Gresham was an orphan and as was the custom in those days he was apprenticed to learn a trade. He ran away and joined the American Forces and fought for his country as a private in the Continental Line in the War of the Revolution. Record of 100 acres of land allowed him for his services may be found in the Virginia land office, Richmond Va. (Then, list of children of John Gresham & Martha W. Scott Gresham).

The State vs Leroy Upshaw) Ultering (sic) and passing counterfeit guineas.

The prisoner Leroy Upshaw was indicted for falsely altering and passing to one John Gresham, two counterfeit guineas, of base metal, of the likeness and similitude of English guineas; knowing them to be base and counterfeit as aforesaid, contrary to an act of the General Assembly.

At the trial of this case the aforesaid John Gresham, produced in court two guineas which had every appearance of base metal, and the said Gresham being examined on oath sayeth, that he received the two guineas aforesaid of the prisoner with four others which were good, in discharge of a debt; that some time after he informed the prisoner that the two guineas were counterfeit; when the prisoner told him that if they were he did not know it and that he would pay him other money for them; ten or twelve days after the prisoner came again to his house, and informed him he had part of the money to redeem the two guineas that were supposed to be counterfeit, which he refused to receive until he could pay him the whole; at another time, after he had obtained a warrant against the prisoner. he, the prisoner, applied to pay him other money for the two guineas, but he refused to receive it. It further appeared that some short time before Upshaw paid the money to Gresham, he had received in Virginia a considerable sum of money in gold, and at the time of payment produced to Mr. Gresham a number of guineas, out of which he took such as he liked, and weighed them himself. The jury found the prisoner not guilty.

It is very possible that the name is a variant spelling of a place called UPSHIRE in Essex, England. The meaning could be "Upper shire" in the sense of a small district and not a county.
