THE EDITORS DESK



This issue contains all material from our files for the states of Arkansas and Mississippi. Particularily interesting to me is the <u>Demima Upshaw</u>, age 63, enumerated in the household of Elisha Starling in 1850 Randolph County, Arkansas. It is interesting to note that the eldest son of Elisha and Elizabeth Starling is named William and the second eldest son is named Midleton(sic). This family was in Alabama circa 1830-1838 and in Georgia circa 1839-1848, which coincides with the movements of the William and Middleton Upshaw families.

Please refer to UFJ, Vol II page 82, for the 1830 Jackson County, Alabama, census where two "Elisha Sterling" households - probably "Sr." and "Jr." - are found living between the families of William Upshaw and Middleton Upshaw. Furthermore, the family of Elisha Sterling is found in Walker County, Georgia, in the 1840 census (page 81), as was the Middleton Upshaw family (see UFJ, Vol I page 58).

The conclusion may be drawn that Demima, born 1787 in Tennessee, was the wife of William Upshaw and thus, the mother of Middleton Upshaw. It may also be concluded that Elizabeth, wife of Elisha Sterling, was Elizabeth Upshaw, daughter of William and Demima Upshaw; thus was Demima, as a widow, living with her daughter and son-in-law in 1850. I feel the identification of these persons and their relationships is of great importance, especially when we consider that these descendants of Leroy and Elizabeth (Bradley) Upshaw were previously not known.

Cornelia Upshaw, widow of T. L. Upshaw, P. O. Helena, Phillips County, Arkansas. Cornelia Upshaw, born 7 Sep 1842, widow of T. L. Upshaw who served as a soldier in the army of the Confederate States, being a member of: "(see Adjutant General report and Mrs. Cornelia Upshaw letter)"; her said husband died 13 Dec 1900. Signed: Cornelia (X) Upshaw, 25 Jun 1925.

2) Statement, county and probate clerk, Helena, Arkansas, not dated:

"Guards & pickets C. S. A. will pass T. L. Upshaw (special scout) through our lines until further orders, by Cmd. Capt. Thos. Henderson (Chief of Scouts) via B. F. Harbert, Cmdg. Memphis Scouts Mch 19/65."

"Attest a true copy of pass, believed to be the original and genuine pass, as exhibited to me"; signed, C. P. Sanders, county clerk.

3) Military Service Record, from the Adjutant General's office, War Department. Washington, D. C.; dated 8 May 1925: (Returned to Mr. C. P. Sanders, county clerk, Helena, Arkansas)

The records show that Co. E, 9th Mississippi Inf., C.S.A. was known as "The Horn Lake Volunteers".

No record has been found of the service, capture or parole of Thomas L. Upshaw, as of that organization.

Muster roll Mch. 12 to May 1, 1862 (latest on file) shows him present, a Private.

30, 1864 (latest on file).

Other records show that T. L. Upshaw, Jackson's Regt. Tenn. Cav., C.S.A., received at Granada, Miss., on Dec. 30, 1862, from A.Q.M., C.S.A., pay for one horse shot near Abbeville.

Transferred from Co. A, Jackson's Regt., date not shown, was, Discharged by reason of furnishing a substitute, date not shown.

4) Letter, of Mrs. Cornelia Upshaw, undated:

Wednesday

Dear Julia;

Your letter just received which I will hasten to answer. Mr. Upshaw joined a company from Memphis, the Captain of this company was William Taylor. I don't remember the name of the co. They were with Jackson's Regiment; at one time called Jackson's Body Guard. They were camped for some time at Abbeville, Miss., but I do not know anything about a horse being shot and paid for.

While in the army he had measles which settled on his bowels, and later developed into chronic diahrea, being unable to discharge the duties of a soldier, his commander gave him permission to come home to recouperate, was at home several weeks, then returned.

Am sorry you and Dick should have so much bother about it, but hope you will yet be successful and I thank you both for your efforts whether you do succeed in getting the pension or not.

I did intend to write you a long letter but want to mail this at once. Thank you for the lovely mother's card, 'tis sweet to be remembered by those we love. Love to each and all, and much for yourself.

"Upshaw" Cemetery; (excerpted from correspondence between Ted O. Brooke and Mrs. Betty Jo Hudson, 11423 Longbrook, Houston, Texas, 77099, in Feb, 1977):

"Follow route 90E out of Ravenden Springs (Ark.), coming to an intersection with route 93. Turn north on route 93 and travel 5 1/2 miles north. You will find a very small creek and on the right is the Eden Church of Christ. Across the road on the left and a few yards further down the road there is an old house and barn still standing, which was the home of Albert J. Upshaw. If I remember correctly he had just been buried in the cemetery that was adjacent to his barn lot fence on the north.

Apparently this cemetery was known as the Upshaw cemetery in 1846 (when our ancestor, Edward Hudson, was buried; marker not found) or at least had been known by that name for some time as it was on Upshaw property.

As I remember, there was a marker for Albert J. Upshaw, but no dates on it heading the fresh grave. We inquired at the home of M. A. Baker on route 93, the closest house, and learned this man or wife was a cousin to Albert J. Upshaw.

Names noted on markers in this very overgrown cemetery include James I. McIlroy, Mary (White) McIlroy, Thomas J. McIlroy, Martin, J. R. Laughry, Laura A. Barnett, James P. & Rose Anna Wells."

(Editor's note: I later wrote the Arkansas Historical Commission in regard to the McIlroy and the Wells family cemeteries which I found listed in an index to transcribed Arkansas cemetery records compiled by the DAR in 1976, to which they replied: "We checked the lists of tombstone inscriptions for both cemeteries and found no Upshaw". Neither are there any Upshaw cemeteries listed in the DAR index for the entire state).
