THE EDITORS DESK



I want to thank all of you for your very kind patience. This, the January, 1980 issue, is being prepared in March, 1982, so I am about 9 issues behind schedule, which I hope to bring current. Although the printing has fallen behind, research has been continuing at a steady pace, and I would like to share with you some of these activities.

I've located and visited over twenty small family cemeteries in Coweta County, Georgia, in an effort to find tombstones of some of the Upshaws who were there in the mid-1800s. Although we found only one, I did make complete transcriptions of these cemeteries and donated them to the Georgia Genealogical Society for publication in their Quarterly. Robert, Ashley, and I really enjoyed each other's company on these trips.

I've located and visited the James Upshaw family cemetery in Bartow County, Ga., again making a complete transcription for the Georgia Genealogical Society Quarterly. I could not have located this without the help of Mr. Ben Maxwell, a descendant, who lives in Rydal, Ga., only about a mile south of the cemetery, which is in basically good condition, although quite overgrown with vines, trees, and partly lies under a large fallen tree. We hope to be able to visit Mr. Maxwell again and clear it. Interestingly enough, in a plowed field within 50 feet are four piles of scattered rock which could be remains of a house foundation from days long gone by.

We stopped in Montgomery, Alabama, last summer while on the way to Florida for vacation, where I was able to visit the Alabama Archives and secure some additional Alabama Upshaw records, particularly from Shelby County cemetery volumes, as well as from other sources.

In November, 1980, I drove one of the two vans of third and fourth grade school children from their school at Mount Paran Christian Learning Center in north Atlanta to Williamsburg, Va., for a field trip of four days. My son Robert went on this trip (a fourth grader) and we had a wonderful time: We had tours in Williamsburg geared especially for the children, allowing them to visit many houses and especially crafts which would be most interesting to them, and we all enjoyed it. I was able to visit the Earl Gregg Swem Library at William and Mary College one afternoon and inspect the research papers of T. T. Upshur, who had done the first research on the Upshur family in the nineteenth century. I did not find a great amount of new material, but I was interested to determine his source of accounting of the traditional story of two brothers, Abel and Arthur, having come to America in the 1630s; Abel the proven progenitor of the Upshur family and Arthur the supposed progenitor of the Upshaw family. These findings were most interesting and will be printed in a future issue of the UFJ dealing with this subject.

Through paid researchers we have had additional research done in the National Archives, the DAR Library in Washington, D.C., and in Arkansas.

(The Editor's Desk, continued):

Dozens of new genealogical books are being published, and I have searched for Upshaw references the ones I have access to at the Georgia Archives in Atlanta. In addition, I have researched the following Georgia County records on microfilm at the Georgia Archives: Bartow County census, deeds, and cemeteries; Carroll County deeds; Coweta County deeds and tax lists; Meriwether County deeds; Walton County deeds and tax lists. A new book is just out on Walton County cemeteries which is helpful, although not included was the Tinsley Upshaw gravesite, which I do have a photograph of. I have found the inventory and sale of the estate of Haston Upshaw in Coweta County in 1849 and in the long list of purchasers at the sale the name of Forrester Upshaw is listed. These papers will be printed in the Coweta County issue of the UFJ.

The "Georgia Room" at the Marietta central library is being revitalized with help from the Northeast Cobb Genealogical and Historical Society and has a growing collection of new genealogical books, many which the Georgia Archives does not have, which I have also researched. They also have a complete file of Georgia census microfilm which I have researched for the 1860, 1870, and 1880 census data of Upshaws in several counties.

I have placed advertising in the Postmark Collectors Club Newsletter and the U.S. (Postal) Cancellation Society Bulletin for possible postmarks or cancellations from the towns of Upshaw, which were in Georgia, Alabama, and Missouri, as well as any other. So far the response to that has been nil, although we need to remember that none of these towns may have had their own postmark but, if they did, we should hear something through these ads.

So, although the publishing is behind schedule, research has been continuing and has not slowed. Our unpublished files contain more Upshaw data than ever before (in spite of the fact that we've already published over 600 typewritten pages of data), and I have several issues ready for typing which I plan for this summer. I believe you will all be pleasantly surprised and encouraged by the Upshaw records which will appear in the next issues. Thank you again for your consideration and patience.

Raleigh W. Upshaw, a pioneer in the marine geophysical exploration field, died Tuesday at Baptist Hospital after a lengthy illness. He was 66.

Funeral services will be held at Leitz-Eagan Funeral Home, 4747 Veterans Blvd. at 2 p.m. Thursday. Interment will be in Metairie Cemetery.

A native of Silsbee, Texas, Mr. Upshaw was a graduate of Texas Tech University. Prior to World War II, he moved to New Orleans and during the war he served as an officer in the Army. A member of the Plimsoll Club and the Petroleum Club, he was vice president of the Southern Geophysical Company until he began his own consulting firm in 1958.

He is survived by his wife, Mrs. (Marie) Goolsby Upshaw, and three sons, Michael Leigh Upshaw, Charles Patrick Upshaw and Stephen Neal Upshaw.



If Hannah Upshaw was the first wife of Thomas Jones I am concerned with (will dtd. 26 Dec. 1738, pro. 20 Mar. 1738/39), I may have narrowed the time frame for her marriage and subsequent death. Hannah was evidently unmarried when mentioned in her father's will, probated 1720; and if she was Thomas' first wife, would have died prior to 1725/26 when Thomas was married to my Mary.

If there were two Thomas Jones who died about the same time. and I have simply not found record of the other, it becomes very confusing for the documents I have been using to substantiate the children of Thomas and Mary are the same as the documents Mrs. Sweeney uses for substantiating the children of Thomas and Hannah.

Not a correction, but some additional information comes from Mrs. Melba U. Twitty, in a letter to myself dated 19 Aug. 1980. She comments that "The Arkansas Confederate Pension presented in UFJ, Vol. VI, pg. 79-80, of Cornelia (Mrs. T. L.) Upshaw refers to Thomas Lewis Tazewell Upshaw, a son of Mason Tazewell B. Upshaw (son of Capt. James Upshaw). Thomas L. T. Upshaw married Cornelia Morse and they had a son, Morse Kilburn Upshaw, who married Julia Chew. They lived in Arkansas and some descendants lived in Marianna, Lee County. Other descendants of Mason T. B. Upshaw went to Oklahoma. This information was in some notes sent to me by Mrs. Jared from data compiled by Mrs. Harry Jay of Memphis. Tenn., and I believe sent to Mrs. Jared by Mrs. Morse Kilburn Upshaw, Jr., of Jackson, Miss. I think Thomas Lewis Tazewell Upshaw was probably born circa 1835."

In addition to Judge Lipscomb's daughters, his granddaughters, Betsy Gaines (Mrs. E. M. Underhill), Ellen (Mrs. P. D. L. Hilliard), and Salina "Lena" (Mrs. Weston Bailey), daughters of William Bibb Lipscomb, attended the same school. It was also patronized by two nieces of the jurist, Mary "Mollie" and Fannie Bishop (Mrs. J. M. Lanham). Another granddaughter, Bettie Upshaw (Mrs. H. H. Jones) was a student in Austin "when Dr. S. C. Red graduated from the University and when Mrs. R. K. Red died."

One of Chappell Hill's early settlers, <u>Col. A. M. M. Upshaw</u>, was elected a representative to the Texas Legislature from Washington County in 1857, and also in 1859. Although he lived in an educational center, he too selected the Gay Hill seminary for his daughters, <u>Julia</u> (Mrs. Samuel Reese Blake of Bellville) and <u>Louise</u> "Tea" (Mrs. Calvin Blake of Houston).²⁰

Col. Upshaw's three daughters-in-law, Mrs. Robert L. Upshaw (Bettie D. Lipscomb), Mrs. Samuel Crockett Upshaw (Attillia Aldridge), and Mrs. Harney Upshaw (Lucy Lipscomb), were all students at the same popular school. The daughters of Dr. and Mrs. Harney Upshaw, Julia (Mrs. Joe Mills) and Bettie (Mrs. Harry H. Jones), learned the rudiments at the old seminary after it became a day school; and later, Bettie followed Mrs. Red to Austin where she joined her cousins, Kate Upshaw (Mrs. George Irby Jordan) and Annie Upshaw, (Mrs. John Luther Cleveland), daughters of Judge and Mrs. S. C. Upshaw of Hillsboro, at Stuart Seminary.

FORMER RESIDENT DIED AT OAK CLIFF

Bellville Times (Bellville, Texas)

Maj. Robert L. Upshaw died at his home in Oak Cliff, Dallas, Texas on July 5, 1912.

Maj. Upshaw was the oldest son of Gen. A. M. Upshaw, late of Washington County and long since deceased, and was born in Pulaski, Tenn. in 1833.

He was graduated of the Kentucky Military Institute and followed the profession of civil engineer in the state of Indiana prior to coming to Texas in 1852 after which he followed the same line as an employe of the Houston and Texas Central railroad, the state's oldest road.

At the outbreak of the Civil War he entered the services of the Confederacy and served as adjutant on the staff of Gen. Walker, being taken prisoner at the battle of Mansfield.

After the close of the war he returned to Texas and later held a government position in the state of Montana for the period of eight years at which time he returned to Texas and made his home in Oak Cliff.

He again entered the service of the Central railroad and held a place with that road until the failure of his health a few years since.

He was a gentleman of the old school, refined in manner and of the highest sense of honor.

He was twice married, his first wife being Miss Bettie Lipscomb, daughter of Judge Abner Lipscomb. His second was Miss Adelle Graves, who survives him.

Mrs. S. R. Blake, formerly of Bellville and Mrs. Louise Blake of Houston are his sisters and Dr. Harney Upshaw of Somerville is a brother. Maj. Upshaw is well remembered by many of our older citizens.

Pruitt, who notes that this schedule of separate property was filed by Ann Hamilton (Crockett) Upshaw, wife of Arthur Martin Montgomery Upshaw, in Washington Co., Texas, dated 24 July 1850. This schedule is particularly interesting in view of the fact that Ann and her husband, Arthur M. M. Upshaw, had been married some 20 years prior to the execution of this instrument.)

Know all men by this that I, Ann H. Upshaw, wife of A. M. M. Upshaw, late of the Chickasaw Nation and now of the County of Washington and State of Texas do hereby these presents in accordance with the act of the legislature of the State of Texas entitled "An Act to Provide for the Registration of the Separate Property of Married Women", passed and approved on the 29th April 184(1?),

render and return a schedule of my separate and individual property which I now claim and hold in my own right, to wit: the following named negroes: Jim, a man 30 years of age, black complexion, 6 feet high; Mahala, with three young children, Lewis 4 years, Jim 2 years, and infant about 5 months; Elias, a fellow 27 years of age, a yellow complexion; Mary, a woman 30 years old, yellow complexion and her children, 12 years of age, George, ten years (an albino), Lucy 8 years yellow, Mander 5 years yellow, Duncan 3 years yellow, an infant girl (an albino); Sarah, a black woman 34 years old; Caroline, a black woman 22 years old; Tom, a yellow boy 17 years of age; Allen, a negro fellow 20 years of age, yellow complexion, over six feet high and now in the Chickasaw nation; one wagon and 3 horses, one bay, one sorrel and grey pony; 4 mules, three bay and one sorrel branded U and AU; a pleasure carriage and 75 head of sheep and household and kitchen furniture. Also a tract of land which I have contracted to purchase of J. B. Banks in the County of Washington and said state on Caney Creek containing $483\frac{1}{2}$ acres, a more full reference is made to the deed than when admitted to record from said Banks to me in this county. Given under my hand and seal this 24 July 1850.

Mrs. Adele Graves Upshaw; 1910 Nueces St., Austin, Travis Co., Texas; filed 15 Aug 1924, approved 14 Oct 1924, pension allowed from 1 Sep 1924.

1) Widow's Application for a Confederate Pension.

Mrs. Adele Graves Upshaw, widow of Robert Lewis Upshaw, deceased, who died on 22 July 1912 in Dallas Co., Texas. They were married on 23 Dec 1875 in Lee Co., Tex.

She is 66 years old, born in Cypress, Texas and has resided in Texas all

her life, residing at her present address of 1910 Nueces St., Austin, Travis Co., Texas for about 6 years. Her husband, Robert Lewis Upshaw, did not draw a pension.

He enlisted in September 1861 and served until the close of the war. He was in Texas Artillery, transferred Nov. 1861, to 16th Texas Infantry, Walker's Division. He served as Adt. General, Walker's Division. He served in the Infantry, detailed as Inspector General, and served in that capacity most of the war. Signed 15 Aug. 1924 by Mrs. Adele Graves Upshaw.

- 2) Affidavit of Witnesses Joseph D. Sayers and T. H. Barrow, 5 Aug. 1924,
 "That Mrs. Adele Graves Upshaw, applicant for a pension as the widow of
 Robert Lewis Upshaw, deceased, is in truth and fact the widow of Robert Lewis
 Upshaw, deceased" and "that the said Mrs. Adele Graves Upshaw has been a bona
 fide resident of Texas since prior to Jan. 1, 1900."
- 3) Affidavit of witness Joseph D. Sayers, 5 Aug. 1924, that "I personally know that the said Robert L. Upshaw was in the actual military service of the Confederate States during our Civil War."

At present, her homestead valued at "None" on the tax rolls of Travis County.

4) Memorandum written by Robert L. Upshaw:

The purpose of this paper is to perpetuate evidence by which my wife may, after my death, secure a pension from the State of Texas, on account of my services in the Confederate States Army.

I was born near Elkton, Giles Co., Tennessee, May 8th, 1833. Have been twice married; lst to Betty Duke Lipscomb, daughter of Judge Abner S. Lipscomb, and his wife, Mary P. Lipscomb, June 23, 1860. Said first wife died March 23rd, 1873, without issue. Second, to Adele Graves, daughter of Dr. Leonidas Graves and his wife, Mary Graves, on the 23rd of December, 1875. She has been and is now a good wife to me, ministering to me in sickness and in health, in many adverse circumstances requiring courage and fortitude to a remarkable degree.

About Sept. 20th I was appointed by Gen. P. O. Hebert Comdg. Trans-Miss. Dept., 1st Lt. of Artillery, and was assigned to Engr. duty at Pelican Spit in Galveston Bay - about Nov. 1861 was transferred to Flournoy's 16th Texas Infantry, then being organized, as Adjutant at Camp Grace near Hempstead, Texas. After organization of the Regt. it was ordered to Virginia Point near Galveston -Then ordered back to Camp Grace and fitted out for a march to Arkansas - where at Camp Nelson, near Austin, Arkansas, about Sept. 26th, we were Brigaded with Waterhouse's 19th Texas Infantry, Fitzhugh's 16th Tex. Cavalry, Allen's 17th Inf., Flournoy's 16th Inf. - Edgar's Battery - The Brigade was assigned to D Division and not long afterward to Command of Gen. McCullough, then to command of Maj. Gen. J. G. Walker - on the organization of then Brigade I was detailed as Adj.Gen. and was in that position as Inspector Gen. for most part of the war, at close being on Gen. John H. Forney's Staff as Inspector Gen. of the Division, -Gen. W. H. King being in actual command of the Div'n - at the time of the surrender - of the Trans Miss. Dept. I was in all the engagements of Walker's Division except the battle of Jenkins Ferry, Ark., at which time I was a prisoner, having been captured by the enemy at Pleasant Hill, La.

Copy of Memorandum Written by Robert L. Upshaw.

5) <u>Military Service Record</u> of R. L. Upshaw, as reported to Comptroller, State of Texas, from the War Dept., Adjutant General's Office, Washington, D.C., 6 Oct. 1924:

The records show that R. L. Upshaw was appointed Adjt. 16th (Flournoys) Tex. Inf., C.S.A., Oct. 17, 1861, was appointed Actg. Asst. Adjt. Gen. Oct. 2, 1862, and on Muster Roll of F. & S. for Jan. & Feb. 1864. (Last on file) is shown, Absent, A.A.A.&I. Gen. of Brigade on detached service. Regimental return for Apr. 1865 shows him at Hempstead, Tex. A.A.A.& Ins. Gen. on Maj. Gen. Forney's staff, Spec. Ord. no. 60 Dec. 23, 1864. Div. Hd. Qrs. No later record has been found. Prisoner of War records shows that as 1st Lt. and Ins. Gen. Sucrry's Brig. Tex. he was captured Apr. 9, 1864 at Pleasant Hill, paroled at New Orleans, date not shown, and was transferred to and exchanged at Red River Ldg. July 22, 1864 No record has been found of a previous call for the above service.

Harney Upshaw; Somerville, Burleson Co., Texas; filed 30 July 1913, approved 1 Sep. 1913, pension allowed from 1 Dec. 1913.

1) Soldier's Application for Pension who is in Indigent Circumstances:

Harney Upshaw was honorably discharged or surrendered at Houston, Texas, at close of the war. 67 years old, born at Ft. Washita, Indian Territory, resided in Texas "since in 1850", has now been residing in Sommerville, Burleson Co., Texas, about 12 years. His occupation is "Physician, but not able to work".

He enlisted in the Spring of 1864 and served until close of the war in Co. "F", 5th Texas Mounted Volunteers, a Cavalry unit.

At present, his "Homestead valued at \$700 on tax rolls". Signed 7 July 1913 by Harney Upshaw.

- 2) Affidavit of Witnesses W. C. Broesche, Notary Public, and W. A. Lyons, 7 July 1913, "That they personally know that the said Harney Upshaw has been a bona fide resident citizen of the State of Texas since prior to January 1, 1880."
- 3) Affidavit of witness W. A. Lyons, 7 July 1913, "That he knows H. Upshaw was in the Confederate Army because he was a member of the same regiment and knew him in the service, saw him in the actual service and saw him performing the duties of a soldier and was with him when we were discharged at Houston, Texas, and know he made a good soldier and did not desert. He was a member of Co. "F" and I (a) member of Co. "E".
- 4) Affidavit of Witness W. C. Broesche, 14 July 1913, (similar to above, with the additional information:) Harney Upshaw was a member of Company "F" 5th Texas Mounted Volunteers, Gen'l Green's original regiment and Green's Brigade. I was a member of Co. "E" of the same regiment, we were discharged together at Houston, Texas, on or about the 20th of May 1865.

Mrs. Lizzie Upshaw; Somerville (Burleson Co.) Texas; filed 3 May 1915, approved 8 May 1915, pension allowed from 1 Sep. 1915.

1) Application of Widows of Soldiers in Indigent Circumstances.

Mrs. Lizzie Upshaw, widow of Dr. H. Upshaw, deceased, who died 27 Mar. 1915
in Burleson Co., Texas. They were married on 29 Dec. 1875 in Washington Co., Texas.

She was 64 years old on Apr. 4, 1915, born in Austin Co., Texas and has resided in Texas all her life, residing at her present address of Somerville, Burleson Co., Texas, about 15 years. Her husband, Harney Upshaw, was born 23 Feb. 1846. (Editor's note: on this application, this date is incorrectly stated to be "the date of his death".)

He joined the 5th Texas Cavalry, Green's Brigade, in 1862 or 1863 and served until close of the war; see his Pension Application No. 22196. Signed 30 Apr. 1915 by Mrs. Lizzie Upshaw.

- 2) Affidavit of Witnesses Mrs. Bettie D. Merrin and Charles S. Williams, 30 Apr. 1915, that Mrs. Lizzie Upshaw is the widow of Dr. H. Upshaw and that she has been a resident of Texas since prior to 1 Jan. 1900.
- 3) Affidavit of Witnesses Charles S. Williams and R. J. Alexander, 30 Apr. 1915, that "We know nothing personally about H. Upshaw having served in the Confederate Army but we do know that he was known as a Confederate Soldier and was drawing a Confederate Pension at the time of his death and for proof we refer you to his Application No. 22196."
- 4) Certificate of State and County Assessor that Mrs. Lizzie Upshaw has estate valued at \$700.00, 30 Apr. 1915.
- 5) Affidavit of Mrs. Lizzie Upshaw, widow of H. Upshaw, deceased, 30 Apr. 1915, that the same conditions exist as did at the time of her husband's Pension Application.

Thomas Allen Upshaw; Holland, Bell Co., Texas. Filed 18 Aug. 1909, rejected 31 Aug. 1909 (because of ownership of property valued in excess of \$1,000.)

1) Soldier's Application for Pension; Soldiers who are in Indigent Circumstances:

Thomas Allen Upshaw surrendered at Appomattox Court House in April 1865. 78 years old, born in Bibb County, Alabama, resided in Texas since fall of 1867, has now resided in Holland, Bell Co., Texas, for 41 years. He is not able to engage in any occupation.

He served from April 1862 to 1865 in Co. "H", 9th Louisiana Infantry Regiment - Capt. Shively - Capt. Cook killed at Fredericksburg - Hayes Brigade. He was commissioned as Second Lieut. and afterwards elected First Lieut.

- 2) Affidavit of Witnesses S. A. Pearce and W. W. Upshaw, 7 Aug. 1909, "That T. A. Upshaw has been a bona fide resident citizen of Texas since prior to January 1, 1880.
- 3) Affidavit of Witness S. A. Pearce, 7 Aug. 1909, who says "that he personally knows Thomas Allen Upshaw, and has known him for a long time that he served in the same company with Upshaw during the War Between the States of the United States and that he personally knows that T. A. Upshaw was a gallant soldier, and did his duty well. That they were in Co. "H", 9th Louisiana Regiment Captain Cook was captain when T. A. Upshaw went into company; Capt. Gray was Capt. of Company before T. A. Upshaw joined Taylor's Brigade."

- 4) Affidavit of witness W. W. Upshaw, 7 Aug. 1909, who "says that he is personally acquainted with Thomas Allen Upshaw, that he served in the same company with said Thomas Allen Upshaw to wit: Company "H", 9th La. Regiment, Taylor's Brigade, afterwards Hay's Brigade, La. Infty., Army of Northern Virginia; that said T. A. Upshaw was 1st Lieut. of said Co. was twice wounded in battle, was a faithful soldier."
- 5) Certificate of the State and County Assessor that, at present, his estate (real and personal) is valued at \$1100 on the Tax Rolls of Bell County, 10 Aug. 1909.
- 6) Military Service Record of Thomas A. Upshaw, as reported to Commissioner of Pensions, State of Texas, from the War Dept., Adjutant General's Office, 18 Sep. 1909:
