Our member, Mrs. Vivian E. Cole of San Diego, California, has sent a copy of all Upshaw names and addresses listed in "The Upshaw Family Heritage Book" by Beatrice Bayley, Inc. This is a current listing of 1,517 Upshaws in the United States, arranged by zip code. I will be glad to search the list for any Upshaw name and send the current address, if found, to anyone sending a SASE with their request. This is an ideal way to locate an Upshaw relative whom we may have lost contact with over the years, so take advantage of this comprehensive list if you would like.

These so-called "Family Heritage Books" by Beatrice Bayley, Inc., are similar in content and format; they contain some <u>very general</u> information in the front, which pertains to no family in particular, and also has a list of current names and addresses in the back. They contain no genealogical research or "Family Heritage" of any kind, and I would advise that you should not purchase this type of book by Beatrice Bayley, Inc. (on Upshaw or any other surname, for that matter) unless you wish to pay for the list of current names and addresses. Their advertising is not carried in reputable genealogical magazines, such as the <u>Genealogical Helper</u>, but is directed toward the general public, who are

subject to being misled by their description of these "Family Heritage" books. Please keep this in mind if such advertising comes to you.

Mrs. Cole also reports this bit of Upshaw trivia: "In the spring of 1980, registered with Social Security were 6,363 Upshaws ... This information came from a SS computer in San Francisco at a health conference attended by Mrs. John W. Upshaw of Hayden, Arizona."

Mrs. Cole has also sent us an article from the Copper Basin News, Hayden, Arizona, Wednesday, May 5, 1982, concerning a picnic held in Hayden. She comments that "Mentioned in the article are children of George Rohn and Jessie Upshaw: Emmaline King, Jake and Beverly Upshaw, and Fred and Gussie White Upshaw. Children of Charles Blake and Alice Upshaw: Blake Upshaw, Ray and Nettie Upshaw, and not mentioned in the article, but in attendance, Irene Ferguson. Someone jokingly suggested that the name be changed from 'Hayden Reunion Picnic' to the 'Upshaw Family Reunion'."

Singleton Hall Plantation

Thomas T. Singleton was one of the early settlers of Silver Creek. On November 18, 1851 he was married to Miss Adeline Hill by James R. West, Minister of the Gospel as recorded in Marriage Book A, page 322, Yazoo County, Mississippi. Miss Hill was the daughter of William Randolph Hill of the neighboring plantation.

A few years after his marriage, Mr. Singleton began the erection of a home. Evidently he became ill before its completion, for his Will, dated April 7, 1860 (Will Book A, page 276, Yazoo County, Mississippi), requested that his property - land and slaves - be equally divided between his wife and his daughter, Betty Randolph Singleton; that the mansion and necessary outbuildings be completed and that his good friends, R. W. Hill, J. R. Hill, A. P. Hill and J. S. Reid serve without bond in seeing that his bequests be executed.

Betty Randolph Singleton was married to William E. Upshaw on April 14, 1870 (Book D, page 347, Marriage Records, Yazoo County, Mississippi), and they were the parents of one daughter, Annie Lou Upshaw, who was married to Frank L. Gordon. A daughter, Bettie, was born to this union on July 19, 1903. She was married in 1923 to B. J. Kern and passed away on August 3, 1958 after a lingering illness. She is survived by two daughters, Mrs. Jane Kern Kellum, and Mrs. Betty Lou Fleming, and one son, B. J. Kern, Jr.

Betty Randolph Singleton Upshaw was married a second time. On May 20, 1885 at Singleton Hall, she married her brother-in-law, Samuel Ruffin Upshaw. Their daughter, Bessie Hill Upshaw, married her brother-in-law, F. L. Gordon. They were the parents of one son, F. L. Gordon, Jr., who with his family now lives in Louisa.

Adalene Singleton Upshaw, daughter of Samuel Ruffin Upshaw and his wife, Betty Randolph Singleton Upshaw, was married on February 23, 1919 to Bartlett Wade Smith of Claiborne County, Mississippi. They have two sons, Samuel Upshaw Smith and B. W. Smith, Jr., who with their families make their home here.

Samuel Ruffin Upshaw died June 7, 1941 and is buried in Glenwood Cemetery, Yazoo City, Mississippi. Mrs. Upshaw and other members of her family are buried in the family cemetery on the plantation.

"Daddy Sam", as Mr. Upshaw was more familiarly known, was a well-known figure along Main Street. He wore a goatee and carried a walking cane which made him easily recognized. Well-read and informed on the happenings of the day, he looked forward to each election year when he could extoll the virtues of his favorite candidate, and with equal fervor, banish those he did not like to oblivion.

The J. D. Upshaw Family

Just across the creek from the big house on Singleton Hall plantation there was, around the turn of the century, a general store and postoffice, the name of which was UPSHAW. Mr. Jefferson Davis Upshaw being the Postmaster.

It was to this place that Mr. Upshaw took his bride, the former Etna Ann Brown of Deasonville, after their marriage on August 24, 1904.

Soon after this, the Yazoo & Mississippi Valley Railroad Company made plans to extend their lines from Silver City to _elso, and Mr. Upshaw, thinking that the railroad would pass through his property, looked forward to the Postoffice being on the railroad. In fact, he was so sure that this would be so that a sign was made pointing to the little settlement. When the survey was completed, however, it was found that the line would pass through Big Bend Plantation, which was owned by William H. Reid.

In 1906, when Mr. Reid laid off a town on his property and called it LOUISE, Mr. and Mrs. Upshaw acquired both a business and residential lot from him and built a frame store and home, which were the first buildings erected in the new town. The store burned in a few years, to be replaced by a two-story brick building, but the home stands today and belongs to Mr. and Mrs. B. A. Holaday, Sr.

When Mr. Upshaw's health required that he seek a warmer climate, the family moved to El Paso, Texas, where they lived until he passed away, when Mrs. Upshaw and their two children, J. D. Upshaw, Jr. and Alexandria (now Mrs. B. J. Barrier) returned to Louise to make their home.

Mrs. Upshaw now makes her home in Yazoo City with her daughter, and the family home is now occupied by J. D. Upshaw, Jr. and his wife, the former Christine Ferguson, who came here in 1927 to teach in the Louise School. Both are active in the work of the Louise Methodist Church. Their son, Jefferson Davis Upshaw, prepared for the medical profession at the University of Alabama and Johns Hopkins and is now practicing in Memphis, Tennessee. He is married to the former Marie Hall of Memphis, and they are the parents of Christy and Jefferson Davis Upshaw 3rd.

When William Randolph Hill died, his heirs were Nancy M. Hill, wife; Joseph R. Hill, son; Adaline Hill Lyons, daughter; Carrie Calhoun, deceased, and Betty Randolph Singleton, grand-daughter. Betty Singleton Upshaw has descendants here.

"Tale of a Mid-South City", from Commercial Appeal (A small article about Louise, Mississippi, evidently copied from another newspaper)

"The first post office was established at this place in 1900 and known as 'Upshaw'. J. D. Upshaw was the first postmaster. In 1906, the railroad came through and was routed through Big Bend Plantation, owned by W. H. Reid. He donated right-of-way with the stipulation that the town be renamed "Louise" for his small daughter. Lumbering has been Louise's prime industry for many years."

(Also included in this installment of the <u>History of Louise</u> is a photocopy of an envelope addressed to Mrs. J. D. Upshaw, Upshaw, Mississippi, dated Dec. 27, 1906, and postmarked "Upshaw" on the reverse.)

LOUISE

Located five miles south of Midnight, this land site was originally owned by the father of W. H. Reid; W. H. Reid later naming the place for his daughter. The post office was first established on the Blue Ruin Plantation and named Upshaw, but the office was later moved to Louise.

The first school was established in an abandoned cotton house made of logs and boasted an attendance of five pupils. In 1907, the railroad was built through Louise, and the village grew rapidly after the coming of the Barr-Holiday Lumber Company in 1916. Early merchants in the town included L. H. Hill and a man named Upshaw.

In the collection of Virginia Miscellany in the Manuscripts Division of the Library of Congress there is a volume entitled Foreign Business and Inquisitions, 1665-1676. This volume was originally a part of the records of the Secretary of the Colony. It came into the possession of the Library of Congress with the Thomas Jefferson manuscripts.

A large portion of the contents of the volume relates to inquisitions to determine whether land had escheated to the crown. The following abstracts relate to these items only.

(p. 194) Northampton Co., Va. 1 March 1671 (1672)
John Stringer, escheator. Jury find that Petter Lang died seized of 400 acres now in the possession of his relict Eliz: Lang and children of Peter Lang named Eliz: Lang, Joane Lang, and further that Peter Lang had onely estate for life, for which cause the land doth escheate.

Letter: G. A. Upshaw to Wife, Dated 25 May 1857:
(Contributed by Mrs. Vivian E. Cole, San Diego, Cal., who comments, "In 1857, George Augustus Upshaw made a long overdue trip to Kentucky and Virginia to settle an estate. There were several letters written by G. A. to his wife Mary Ann, in Belton, Erath Co., Texas, while on this trip. For many years, three of the letters survived and my mother, Irene L. Upshaw, great-granddaughter of G. A., remembers her grandmother, Delphia Upshaw, reading them to her as a child; however, two were lost many years ago.

"I have made every effort to transcribe the remaining letter, now in the possession of my uncle, Raymond C. Upshaw, as accurately as possible." Words shown in question marks or in parentheses are illegible or indistinguishable.

Mrs. Cole's analysis of various parts of this letter will be found following the letter, as indicated by the reference numbers shown on the right.

The letter reads as follows:

Ballad County, Kentucky May 25/57

Dear Wife

Since my last which was directed from Hickmand. There has been some material 2 changes in things in this section as it respects my business, I intended before this time to have been in Virginia; but shall not start untill next Sunday as I am about to sell 500 acres of land, but have not sold any before, it will take me only 3 days from this place to Baltimore then only one to Richmond to attend 3, 4 to the business, I shall be gone about 6 weeks from this place, and then if I can wind up it will be but a short time untill I am at home, for I can tell you that I am getting remarkable tired of being from home and wish to wind up

my business before I come. If I make the sale this week I will send you some money, but if I donot you will have to sell any thing that is on the place and try and fix up as much as possible. I have directed 4 letters to you through G. W. Haly for him to write to me and direct his letters to Blanvill on the 5**,** 6 reception of this write to me at this place as it will meet me hear, on my return from Virginia. I expect that my 2 brother in laws will be out this fall 7 to look at the country, and a number of my particular friends. Corn at this time is just comeing up and that has been the cause of my not being able to sell before this time, and finding the hole business has been nothing done with since 9 Fathers death untill I came and stired it up, as all the rest has pretty near 10 got their part and one would not, nor another so they let it stand, untill I came. I am about to straiten things in this section, then for Virginia for 11, 12 the Administrator he is a brother in law, to our celebrated neighbor James Bag- 13, 16 by, you may guess from that sircumstance how things are there. My land near 14, 15 Mound sitty I intend to hold on as it will not be long before it will be worth \$100 per acre, and the land is not rising so fast that I amabout to dispose of, I shall write you a letter from Hickman as I intend to start from their, I have 17 had a great deel of travel and searching of documents to do and it is a labourous business but in the end will make moore than I could make in (10?) years hard labor, and when I get home I want to stay the ballance of my days.

Thomas, Jackson & Blake, gives me up all of their interest in the Texas land, which I had before, and had rather have their concent, and as for Sam I care nothing.

I am at this time in fine health & spirits, except when I think of home and my poor family, but sircumstances has been so that I could not help myself.

You must be in good spirits and bear up aginst your misfortunes as much as posible, if Stutervill or Sam Evitts kills any Beef and you want tell them 24, 25 they shall be sertain of their money. Thank god when I come, we can then live as well as any of them, but now is the present time, donot suffer.

Thomas maid me a present of a fine suit of clothes from head to foot, that is nothing to him as he is worth \$100,000 dollars and making as fast as any man could wish, his third wife is as fine a woman as he could have got and they are happy, they came up hear last week on a visit to us, but only stayed a short time as he is so business brittle that he cannot stay long from it. When in Virginia I expect to bring out to him, his old Mother, 28 that raised him after Mother died, and Tom intends to take care of her the 29, 30 ballance of her days, as he is able & only 2 children, and I reccommend him 31 for it, it shows the heart.

If you can see or hear from G. W. Haly he has some 4 letters for you, I shall write you from Hickman next Saturday and send you some money and direct the letter to H. Morriss Bellton and if old man (Trimmer?) or any of my friends are going down, you know who they are, send ... it is strange that I have not hird one word from Haly as it was on business of importance to me, as well to you. They have all so given me up the tract of land near Madersonvill of 1500 acres it is worth 30 per acre as said by those that know it.

It is thought verry strange by a great many that (under?) the sircumstances that I should have laid still so long.

Try and take some panes with Sarah & George for I am trying to do some-37**,** 38 thing for them, and you, as for myself I am of but little account and old 39

and wormout, now is the time while I live and am hear to prevent them from being swindled out of theirs just rites, and while my hand is in I intend to keep it in.

The following is my analysis of the letter -- names, places and phrases, etc.:

- l. Ballad County: Blandville, Ballard Co., Kentucky. The home of two of George Augustus Upshaw's sisters. Mary Ann Upshaw, married to Charles Henry Blake, and Lucy Eleanor Upshaw, married to William S. Jackson.
- 2. Hickmand: Hickman, Fulton Co., Ky., home of Thomas Roane Upshaw, brother of G. A. Upshaw.
- 3. Baltimore: The Railroad went north from Hickman to Illinois, east through Indiana, Ohio, Pennsylvania, and then on to Baltimore, Maryland, There was very little track west of the Mississippi at that time.
- 4. Richmond: Only one day by rail to Richmond, where the Administrator of the estate was located.
- 5. 6. G. W. Haley: Neighbor of G.A. in Belton, Texas.
- Blandville: Home of sisters and brothers-in-law, in Ballard Co., Ky.
- Brothers-in-law: Charles Henry Blake and William S. Jackson. 7.
- 8. "My particular friends": Seems to indicate a previous relationship with people in the area, although none are mentioned by name.
- "Nothing done since Father's death": Edwin Upshaw died 2 Feb. 1849. 9. (See next chapter for information on Edwin and the estate.)
- "All the rest has pretty near got their part": This phrase is in reference 10. to the settlement of the estate that had been going on for many years and of which all of Edwin Upshaw's heirs were legatees, as well as many others.
- 11. Virginia: The Administrator. (Note: I believe in stating "For Virginia", he means that he is to go to Virginia, King and Queen Co., to "straighten things" there. - TOB)
- The Administrator: Brother-in-law of James Bagby. 12.
- James Bagby: Neighbor of G.A. in Belton, Texas
- "My land near Mound sitty": Seems to indicate previous ownership from 14. before marriage to Mary Ann Slagle, "My land", not our land.
- Mound sitty: Mound City, Pulaski Co., Ill., is just across the Ohio River 15. from Ballard Co., Ky. My research has turned up nothing there. I keep hoping to find something.
- James Bagby: Neighbor in Belton, Texas. 16.
- Hickman: Home of Thomas Roane Upshaw, brother of G. A.
- Thomas: Thomas Roane Upshaw. 18.
- Jackson: William S. Jackson, brother-in-law of G. A. and husband of sister 19. Lucy Eleanor Upshaw.
- 20. Blake: Charles Henry Blake, brother-in-law of G. A. and husband of sister Mary Ann Upshaw.
- "Their interest in the Texas land". I do not know the meaning of this 21. phrase. Did Edwin Upshaw have land in Texas that his children inherited an interest in??? Could there have been Texas land involved in the estate???

- 22. Sam: Samuel William Upshaw, G. A.'s brother, three years younger than himself.
- 23. "As for Sam I care nothing": There must have been quite a rift between these two brothers.
- 24. Stutervill: Neighbor in Belton, Texas.
- 25. Sam Evitts: Neighbor in Belton, Texas.
- 26. Thomas: Thomas Roane Upshaw, youngest child of the Upshaws.
- 27. "His third wife": Alice Z. Upshaw, maiden name unknown.
- 28. "His old Mother": Thomas Roane Upshaw's negro Mammy. Thomas was only 18 months old when his mother, Lucy Roane Upshaw, died.
- 29. "After Mother died": Lucy Roane Upshaw died 23 October 1814.
- 30. Tom: Thomas Roane Upshaw.
- 31. "2 children": John R. Upshaw, b. ca. 1845, and Hugh (L.) Upshaw, b. ca. 1848.
- 32. G. W. Haly: Neighbor in Belton, Texas.
- 33. H. Morrifs: H. Moriss of Belton, Texas.
- 34. Old man (Trisnnuer, Trimmer?): Friend of G. A. in Texas.
- 35. Madersonvill: There is a Madisonville in Kentucky.
- 36. "I should have laid still so long": It was 8 years after the death of Edwin Upshaw, and no one did anything about settling this complicated estate.
- 37. Sarah: Sarah M. Upshaw, daughter of G. A. and Mary Ann Upshaw.
- 38. George: George Rhone Upshaw, son of G. A. and Mary Ann Upshaw.
- 39. "Old and wornout": G. A. Upshaw was 55 years old at the time this letter was written and I think, very tired.

Thomas Roane Upshaw, son of Edwin and Lucy (Roane) Upshaw and younger brother of George Augustus Upshaw, was supposedly in possession of the Family Bible when it was lost during a river crossing, while his family was moving.

- The only two children of George Augustus and Mary (Slagle) Upshaw were:
 (1) Sarah Upshaw, who married William Hughes and lived in Stephenville (Erath Co.), Texas, and raised their family there. After the untimely death of her father, G. A. Upshaw, it is believed that the Hughes family received his property in the vicinity of Stephenville.
- (2) George Rhone (pronounced Roane) Upshaw, who was born in 1849, died in 1898, and married Delphia Catherine Blair.
