Family Sketch

Allen Jones Upshaw of Natchitoches, Winn & Grant Parishes, Louisiana (contributed by UFJ member Mrs. A.M. Smith)

In 1843 Allen Jones Upshaw lived in St. Maurice, Grant Parish, Louisiana; Grant Parish was formed from Winn & Rapides Parishes in 1869, Winn Parish was formed from Natchitoches Parish in 1851. Evidently, Allen Jones Upshaw first lived in Natchitoches Parish, Louisiana, as early as 1841.

Natchitoches Parish deeds do not reveal any pertinent data, as most of the proceedings that Allen J. Upshaw was involved in were sales of slaves, or else had perhaps been removed from the records, which was a common problem in the early 1900s.

Allen J. Upshaw lived in Winn Parish in 1864, where he is listed as a taxpayer and he sold land in 1868. He and his family lived in Grant Parish for some time, directly across the border between Natchitoches and Grant Parishes. There is a creek near where they lived named "Upshaw Creek".

Alice (Howell) Stahl, daughter of Thomas and Louisiana (Upshaw) Howell, lived with Allen and Mary Upshaw after the death of her mother. When Thomas W. Howell married again, to Annie Hayes, there was some dispute. Mother thought that the Upshaws wanted to have Alice Howell continue to live there with them and that the new wife was very opposed. Whatever happened, it caused sufficient hard feelings on the part of the new wife that no association with the Upshaws was allowed after that.

Upshow(sic), Alex. W.:

Pvt., Co. I, 31st Louisiana Infantry. Federal rolls of prisoners of war show him as captured and paroled at Vicksburg, Mississippi, July 4, 1863.

(Mr. Tim Hudson adds the following notes regarding the 31st Louisiana Infantry regiment): The 31st Louisiana Infantry was the last unit of regular infantry to be mustered into Confederate service, sometime in March or April, 1862. Although it's "enlistment headquarters" was in Monroe, La., many persons from Union Parish are in this unit. For example, I personally have three ggg grandfathers, two ggg uncles and one gggg uncle who lived in Union Parish who were in the 31st Louisiana Infantry, CSA. From Booth's Louisiana *Records*, Sparrow Cadets was the nickname of Co. I, 31st Louisiana Infantry. I know this about the unit from other ancestor's records: This unit was formed in Monroe, La., in the spring of 1862. It began as Capt. Sidney M. Griffin's Company of Infantry. Note that S.H. Griffin was from Union Parish and was a witness to a land deed of A.W. Upshaw dated Dec. 20, 1860. This unit participated in many skirmishes in late 1862 and 1863 and was the main force of Confederates in the Battle of Grand Gulf, Mississippi, on May 1, 1863. Many men were captured here, including two ggg uncles of mine, and sent to the Union military prison at Alton, Illinois, but were exchanged on June 12, 1863. The 31st defended a large area of the siege lines at Vicksburg, Mississippi, where he was captured and paroled on July 4, 1863, the date of the surrender of Vicksburg. This unit merged in 1864 with other units and became the 22nd Regiment (Consolidated) Louisiana Infantry. In 1864 & 1865 the 31st (22nd Consolidated) successfully defended the Red River and Shreveport from Union Gen. Banks' invasion.

Page 311-312: For a courageous, ambitious, and able physician, New Orleans offered magnificent opportunities. The seemingly paradoxical situation of a soaring population and a soaring death rate guaranteed ample possibilities for those who could succeed. The physicians and surgeons, in the forefront of every epidemic, bore more than their share of the casualties. Under these circumstances, the opportunities for medical advancement in early New Orleans paralleled those of an infantry battalion in combat. A case in point was that of Dr. **William Upshaw**, a military surgeon who had come to Louisiana in 1809 with the Federal troops. A year or so later he announced in the New Orleans papers that he was establishing himself in the

practice of medicine and surgery. Shortly afterwards, on September 2, 1811, his obituary appeared in the *Louisiana Courier*. The account of his death stated that he had died in "the bloom of life." He was described as a sound physician who had studied medicine in England and France. (footnote #38: *Louisiana Courier*, September 2, 1811). The deadly "seasonings as they were called exacted a heavy toll among newly arrived medical men, and tragedies such as that which befell **Dr. Upshaw** were only too frequent.

Page 314: ... cians to resort to the so-called field of honor came close to changing the course of United States history. On February 10, 1811, a **Dr. Upshaw** of Concordia Parish, very likely Surgeon **William Upshaw** of the United States army who died in New Orleans a few months later, fought a duel with Captain Winfield Scott on the Louisiana side of the Mississippi River across from Natchez. The physician had originated or repeated a rumor that the captain had misappropriated funds: a challenge and duel resulted. Captain Scott received a painful scalp wound, but his willingness to defend his honor checked the spread of the rumor (footnote #42: "Ibid", although I do not have a copy of page previous 313 to know what the reference istob) In view of the fact that Captain Scott later led the American forces to victory in the Mexican War and was the Whig candidate for president in 1852, one might well wonder what would have happened if **Dr. Upshaw's** bullet had varied an inch or so.

Page 470: The officers who appeared before the congressional committee in 1810 with one or two exceptions presented a damning indictment of Wilkinson's actions. [General Wilkinson was the commanding officer of the U.S. soldiers stationed in New Orleans circa 1810, who was accused of mistreating them].

Two of the surgeons who appeared before the committee deplored the lack of hospital facilities, medicines, fresh food and cleanliness. Both of them agreed that the scurvy arose from the men having to eat army provisions exclusively, and one, Dr. **William Upshaw**, attributed part of the difficulties to a "want of capacity in many who compose [the medical] staff," (footnote #21: "ibid" although I do not have a copy of previous page 469 to know what the reference is-tob).

The Louisiana Gazette, Friday, 16 February 1810, page 2 col. 4 & page 3 col. 1:

NATCHEZ, February _____ 1810

Communication

On Saturday last a Duel was fought on the Louisiana side of the Mississippi opposite Natchez between Capt. Winfield Scott of the U.S. Artil. and Dr. Upshaw, surgeon in the 5th Infantry, in which the former received a severe wound on the pericanium at the first fire, which for the time ended the affair. The wound of Capt. S. though serious and highly painful is not considered dangerous; the skull being slightly furrowed but not fractured.

The groundwork of the meeting was layed [sic] at New Orleans as far back as last spring, when the parties disputed on the subject of the public character and official conduct of General Wilkinson. Dr. U's continued indisposition and Capt. S's subsequent absence from the armys [sic] prevented any correspondence between them on the subject of their differences until December last, when Dr. U replied to a note of Capt. S's that he would prefer charges against him founded on certain disrespectful words used by Capt. S towards Gen. W in Virginia in the fall of 1808, which

were accordingly charged as "mutiny," and on certain of Capt. S's company transactions which were charged as "conduct unbecoming an officer and a gentleman."

An arrest ensued and a General Court Martial was ordered to investigate the case. But before the court took up the subject, another charge was added by the same person, for disrespect and contempt expressed for Gen. W after the arrest and after Gen. W had resigned all command.

The trial was long and interesting; in the course of it the accused went into evidence to prove the truth of one of his declarations, to wit: that Gen. W was a liar and a scoundrel. How far success crowned the attempt the world will in a short time have an opportunity of judging as it is understood the trial will be published. The court acquitted the accused of the charge for mutiny; found him guilty of only a part of the charge in relation to the company transactions, at the same time expressly acquitting him of every thing fraudulent and ungentlemanly; and also found him guilty of uttering of Gen. W the words "traitor, liar and scoundrel" which were pronounced unofficerlike, and sentenced him to be suspended from all military command and emolument, for the space of twelve months.

There was added to the sentence a recommendation to Gen. Hampton to remit 9 months of the suspension; but for reasons which will no doubt be satisfactory when known, the general declined acting on the recommendation.

It was on publication of his sentence that Capt. S again addressed himself to Dr. U which lead to the meeting above described.

The Louisiana Courier, issue of 2 September 1811, page 2 (?), col. 1; New Orleans, Monday, September 2, 1811:

Died the day before yesterday in the bloom of life, **Dr. William Upshaw**, one of the ablest physicians of this city by the extent of his knowledge in his profession and by the mildness of his manners. Notwithstanding the rapid progress and the redoubled paroxysms of his disease, he finished his earthly career with that calm and resignation that characterizes the just. His last looks were met by a few friends who surrounded his death bed who to the last moment tendered him their affectionate but ineffectual aid. It is cruel to see a man fall a victim to this disease who by his talents and experience would perhaps have contributed to arrest its progress. Dr. Upshaw, after having finished the long and tedious study of medicine in England, had the advantage of

having perfected himself in the celebrated University of Montpelier. To a good and solid education was united a liberality and disintereatedness [sic] of character but little known. Not alone to his friends is his memory dear, the remembrance of his good qualities are consecrated by the regrets and tears of the indigent.

The Louisiana Gazette and Daily Advertiser, issue of 2 September 1811, page 2, col. 3; New Orleans, Monday evening, September 2:

Died, on Saturday evening last, **Dr. William Upshaw**, late surgeon of the 5th regiment of the U.S. Infantry – a native of Virginia. "Tread lightly o'er his ashes, ye men of genius, for he was your *brother* – weed his grave clean, ye men of goodness, for he was your *fellow* – and ye whose heaven-born souls ne'er saw the distressed child of misery pass, without a sigh – drop a tear on the grave of Upshaw, for *such was he*." (*Orleans Gaz.*)

He served as a private in Company I, 31st Louisiana Infantry, Confederate States Army during the war. He fought at Vicksburg, among other Louisiana campaigns. They remained in northern Union Parish for the rest of their lives and had a number of children, many of whose descendants remain there today. Alexander died on 11 Feb 1883. No tombstones have been found for Alexander or Zilleann, but there are two empty spots in the Spearsville cemetery between Rebecca A. Rockett, their daughter who died in 1882, and William Elisha Upshaw, Alexander's brother and it seems likely they are buried there. Zilleann continued to live on her farm after Alexander's death. She and her children sold some of her and Alexander's land on 4 Feb 1892, but she was dead by 16 Nov 1899, when her and Alexander's heirs sold the rest of their old farm that Alexander had bought from Henry Barron in 1853.

5. Henry Callaway Barron was born 4 Dec 1831 in Monroe County, Georgia, according to a statement he made in 1862. Henry served with his brother James and brother-in-law Alexander W.
